REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993 Abhinava College of Professional Studies, Plot No.- 171, Village- Kannauj, Post Office- Mallikapur, Tehsil/Taluka- Kannauj, Dist.- Kannauj, Uttar Pradesh- 209727.. had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Abhinava College of Professional Studies, Plot No.- 171, Village- Kannauj, Post Office- Mallikapur, Tehsil/Taluka- Kannauj, Dist.- Kannauj, Uttar Pradesh- 209727, for B.Ed. Course of Two Year duration for an intake of 100 seats students on 26.12.2012.

AND WHEREAS, the matter was considered by the NRC in its 235th meeting held from 15th to 18th April, 2015 and the Committee decided that recognition to the institution is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution on the following point:-


- The institution has not submitted the reply of Show Cause Notice dt. 04.02.2014 issued to it.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 2009, the Northern Regional Committee hereby refused the recognition of the institution i.e. Abhinava College of Professional Studies, Plot No.- 171, Village- Kannauj, Post Office- Mallikapur, Tehsil/Taluka- Kannauj, Dist.- Kannauj, Uttar Pradesh- 209727, in the B.Ed. course on the grounds mentioned above.

If the institution is not satisfied by the above order they can prefer an appeal to the Council (NCTE, New Delhi) in terms of section 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the issue of this order.
