Refusal Order

WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993, Aravali Education Society, Plot No. – 28/1, Street/Road – Ateli Mandi, Village – Ateli Mandi, P.O – Ateli Mandi, Tehsil/Taluka – Ateli Mandi, Town/City – Ateli Mandi, Distt. – Mahendragarh, Haryana - 123021, had submitted an application to the Northern Regional Committee of NCTE on 31.12.2012 for grant of recognition / permission to the institution i.e. Aravali College of Education, Plot No. – 28/1, Village – Mohindergarh Road, Khor, Ateli, P.O – Ateli Mandi, Tehsil/Taluka – Ateli Mandi, Town/City – Ateli Mandi, Distt. – Mahendragarh, Haryana – 123021 for B.Ed. course of two years duration with an intake of 100 students.

AND, WHEREAS, a deficiency letter was issued on 24.08.2013 to the institution.

AND, WHEREAS, the institution did not submit reply of deficiency letter.

AND, WHEREAS, the matter was placed before the NRC in its 221st meeting held from 15th to 17th November, 2013. The Committee decided as under:-

“The original file of the institution and along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and following observations was made:-

- The institution has not submitted it's reply against deficiency letter issued by NRC.

Hence, NRC decided that Show Cause Notice under section 14/15 (3) (b) of NCTE Act, 1993 be issued to the Institution on the above point and direct the Institution to submit the reply as per the provisions of NCTE Act, 1993 Rules & Regulations within 30 days from the date of issue of Show Cause Notice.”

AND, WHEREAS, a show cause notice was issued on 17.12.2013 to the institution.

AND, WHEREAS, the institution did not submit reply of show cause notice dt. 17.12.2013 and 07.01.2015.

AND, WHEREAS, the matter was placed before the NRC in its 239th meeting held on 30th June & 01st July, 2015. The Committee decided as under:-

“The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made.


- The institution did not submit reply of SCN.

Hence, the Committee decided that recognition/permission to the institution is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.”

NOW, THEREFORE, the Northern Regional Committee hereby refuses recognition under section 14/15(3)(b) of the NCTE Act.1993 to the institution i.e. Aravali College of Education, Plot No. – 28/1, Village – Mohindergarh Road, Khor, Ateli, P.O – Ateli Mandi, Tehsil/Taluka – Ateli Mandi, Town/City – Ateli Mandi, Distt. – Mahendragarh, Haryana – 123021 on the grounds mentioned above.


