REFUSAL ORDER

12 AUG 2015

WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993, Shri Giriraj Maharaj Takniki Siksha Samiti Plot No-1K, Street/ Road-N.H.91, Vill-Ratibhanpur, Post Office- Pipalgawan, Teh/Taluk-Sikandrarao, Town/City- Sikandrarao, Dist- Mahamaya Nagar (UP), State-UP, Pin-204211 had submitted an application to the Northern Regional Committee of NCTE on 25.12.2012 for grant of recognition / permission to the institution i.e. Shri Radha Rani Mahavidyalaya Plot/Khasara No-73k,73kh,74,75,76,77, Plot No. 73k,73kh,74, 75,76,77, Street Number-N.H.91, Vill-Iqbalpur, Post Office- Sikandrarao, Teh/Taluk-Sikandrarao, Town/City- Sikandrarao, Dist- Mahamaya Nagar (UP), State-UP, Pin-204211 for D.El.Ed. Course of two year duration for an intake of 50 students, for academic session 2013-14.

AND WHEREAS, the deficiency letter was issued on 13-06-2013 to the institution. The reply of the deficiency letter was submitted on 26-07-2013 by the institution.

AND, WHEREAS, the matter was considered by the NRC in its 219th Meeting held from September 26th to 29th, 2013 and it was decided to issue show cause notice. Accordingly, a show cause notice was issue to the institution on the following point:

- **Building plan submitted by the institution is not approved by the competent authority.**

AND WHEREAS, a show cause notice was issued to the institution on 07.11.2013.

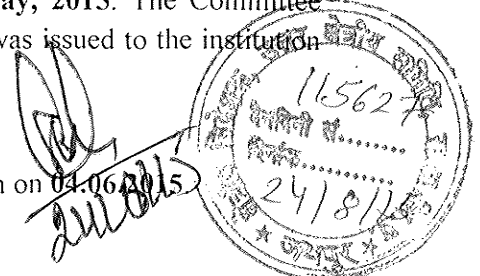
AND WHEREAS, the institution has submitted reply of show cause notice on 06.12.2013 and the case of the institution was considered by NRC in its 222nd Meeting held from December 24th to 28th, 2013 and as per decision of NRC, VT be constituted to verify the infrastructure & instructional facilities created by the Institution for D.El.Ed. Course as per the provisions of NCTE Regulation, 2009, for further processing of the application. The inspection of the institution was conducted on 26.02.2014.

AND WHEREAS, the VTR was placed before the NRC in its 232nd (2nd sitting) held from 9-14 and 16-17 February, 2015. The Committee decided to issue letter of intent under clause 7(13) of NCTE Regulations, 2014 for D.El.Ed course prior to grant of recognition. Accordingly, letter of intent under clause 7(13) was issued to the institution on 17.03.2015.

AND, WHEREAS, the institution has not been submitted reply of show cause notice on till date and the NRC in its 238th meeting (Part-VI) held from 20-31 May, 2015. The Committee decided to issue to show cause notice. Accordingly, a show cause notice was issued to the institution on the following point:

- **The institution has not submitted reply of letter of intent**

AND WHEREAS, a show cause notice was issued to the institution on 04.06.2015




AND, WHEREAS, the reply was considered by NRC in its 240th meeting held from 20th to 22nd July, 2015 and the NRC decided that recognition/permission to the institution is refused u/s 14/15 (3)(b) of the NCTE Act, 1993 on the following point:

- The institution has not submitted reply of SCN.

NOW, THEREFORE, the Northern Regional Committee hereby refuses recognition u/s 14/15 (3) (b) of the NCTE Act, 1993 to the institution i.e. **Shri Radha Rani Mahavidyalaya Plot/Khasara No-73k,73kh,74,75,76,77, Plot No. 73k,73kh,74, 75,76,77, Street Number-N.H.91, Vill-Iqbalpur, Post Office- Sikandrarao, Teh/Taluk-Sikandrarao, Town/City- Sikandrarao, Dist- Mahamaya Nagar (UP), State-UP, Pin-204211** on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order. The guidelines for filing of appeal are available on NCTE website.
