REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Rainbow Public School Shiksha Samiti, Plot Number -129, Street /Road- NH-2, Village/Town/City- Umran, Post Office- Bara, Tehsil/Taluka- Akbarpur, Town/City- Raniya, District- Kanpur Dehat, State- Uttar Pradesh, Pin Code- 209311 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Ram Janki College of Education, Plot / Khasra Number- 129, Street Number- NH 2 Rania, Village- Umran, Post Office- Bara, Tehsil/Taluka- Akbarpur, Town/City- Raniya, District- Kanpur Dehat, State- Uttar Pradesh, Pin Code- 209311 for B.Ed. - Institution did not submit reply of Deficiency Letter.



NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Ram Janki College of Education, Plot / Khasra Number- 129, Street Number- NH 2 Rania, Village- Umran, Post Office- Bara, Tehsil/Taluka- Akbarpur, Town/City- Raniya, District- Kanpur Dehat, State- Uttar Pradesh, Pin Code- 209311 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
