**REFUSAL ORDER**

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Kaushalya Devi Shiksha Samiti, Plot/Khasra Number- 12, Street Number- Sunder Ashram, Village- Sarla Bagh, Post Office- Dayal Bagh, Tehsil/Taluka- Agra, Town/City- Agra, District- Agra (UP), State- UP, Pin Code- 282005 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Posta Kumari Institute of Education, Plot/Khasra Number- 122Kha, Street Number- 0, Village- NA, Post Office- Sarai Neem, Tehsil/Taluka- Jalesar, Town/City- Jalesar, District- Etah (UP), State- UP, Pin Code- 207302 for B.Ed. Course of one year for an intake of 100 seats students on 31.12.2012.

AND WHEREAS, the institution has submitted its reply received in the office of NRC on 29.08.2013. The matter was carefully considered by NRC in its 219<sup>th</sup> Meeting and as per decision of NRC, a VT was issued to the institution.

AND WHEREAS, As per decision of NRC taken in its 236<sup>th</sup> Meeting (Part-III), Show Cause Notice was issued to the institution on 18.05.2015 on the following grounds:-

AND WHEREAS, the institution has not submitted its reply. The matter was carefully considered by NRC in its 241<sup>st</sup> Meeting held on 03<sup>rd</sup> to 07<sup>th</sup> August, 2015 and NRC refused the recognition on the following grounds:-


- The institution has not submitted reply of Show Cause Notice.

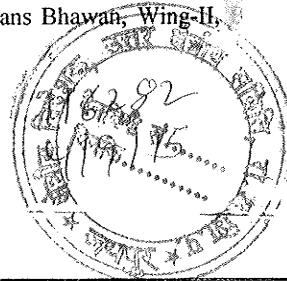


