REFUSAL ORDER

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993, the Society namely, **Brahmarshi Gautam Shiksha Vikas Samiti, Plot No.-139, Village/Town/City-Katka, Post office-Purwa, Tehsil/Taluka-Khajani, Town/City-Gorakhpur, District-Gorakhpur-273407, State-Uttar Pradesh** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/seeking permission to the institution i.e. **Pt. Ram Komal Dwivedi Degree College, Plot No.-139, Village-Katka, Post office-Purwa, Tehsil/Taluka-Khajani, Town/City-Gorakhpur, District-Gorakhpur-273407, State-Uttar Pradesh** for B.Ed. Course in the office of NRC on **01.01.2013**.

AND WHEREAS, a deficiency letter was issued to the institution on 06.05.2013. The reply was considered by NRC in its 220th meeting held from 25th to 29th October, 2013 and NRC decided that VT be constituted. The inspection of the institution was conducted u/s 14 on 26.12.2013.

AND WHEREAS, the VTR was considered by the NRC in its 224th Meeting held from January 28th to February 2nd, 2014 and it was decided to issue show cause notice. Accordingly, Show Cause Notice was issued to the institution on 25.02.2014 on the following points:-

- *The institution has not submitted Building Completion Certificate issued by the Competent Govt. Authority or Local Body Authority.*

AND WHEREAS, the reply was considered by NRC in its 233rd meeting (Part-I) held on February 2015 and NRC decided to issue letter of intent under clause 7(13) of NCTE Regulations, 2014 prior to grant of formal recognition. Accordingly, a letter of intent was issued to the institution on 27.02.2015.

AND WHEREAS, the reply of a letter of intent dated 27.02.2015 has not been received in NRC office till date. The matter was considered by NRC in its 238th Meeting (Part-VI) held from May 20-31, 2015 and it was decided to issue show cause notice. Accordingly, Show Cause Notice was issued to the institution on 04.06.2015 on the following points:-


- *The institution has not submitted reply of letter of intent.*

AND WHEREAS, the reply of a Show Cause Notice dated 04.06.2015 has not been received in NRC office till date. The matter was considered by NRC in its 241st Meeting held from 03rd to 07th August, 2015. The NRC after considering the matter in detail observed/decided the following: -

- *No reply of SCN submitted by the institution after LOI.*

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refused the recognition to the institution i.e. **Pt. Ram Komal Dwivedi Degree College, Plot No.-139, Village-Katka, Post office-Purwa, Tehsil/Taluka-Khajani, Town/City-Gorakhpur, District-Gorakhpur-273407, State-Uttar Pradesh** for B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the issue of this order. The guidelines of appeal are enclosed herewith.
