The matter was considered by the NRC in its 218th Meeting and as per decision taken by NRC the Show Cause Notice issued to the institution on 19.09.2013 on the following grounds:-

Original FDR Rs. 5 lakh in respect of Endowment Fund is not submitted.

AND WHEREAS, the institution has submitted its reply received in the office of NRC on 18.10.2013. The matter was carefully considered by NRC in its 222nd Meeting and as per decision of NRC, a VT was issued to the institution.:-

AND WHEREAS, As per decision of NRC taken in its 237th Meeting, Show Cause Notice was issued to the institution on 17.06.2015 on the following grounds:-

Institution refused for inspection.

AND WHEREAS, the institution has not submitted its reply. The matter was carefully considered by NRC in its 241st Meeting held on 03rd to 07th August, 2015 and NRC refused the recognition on the following grounds:-

The institution has not submitted reply of Show Cause Notice.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Baba Suryabali Sant Saran Das Balika Mahavidyalaya, Plot Number- 136, 138, Street /Road- 0, Village/Town/City- Mirapur Dera B.B., Post Office- Ayodhya, Tehsil/Taluka-Faizabad Sadar, Town/City- Faizabad Sadar, District- Faizabad, State- Uttar Pradesh, Pin Code- 224123 for the B.Ed.
