REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Choudhary Hukam Singh Shikshan Sansthan, Plot Number- 71, Street/Road- B-3, Village/Town/City- Yamuna Vihar, Post Office- Yamuna Vihar, Tehsil/Taluka- Delhi, Town/City- Delhi, District- North East Delhi, Pin Code- 110053, State- DI had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Jeewan Jyoti College of Education for Women, Plot/Khasara No.- 477, Street Number- 0, Village- Faridpur, Post Office- Sikandrabad, Tehsil/Taluka- Sikandrabad, Town/City- Sikandrabad, District- Bulandshahr, Pin Code- 203205, State- Uttar Pradesh for B.Ed. Course of one year for an intake of 100 seats students on 31.12.2012.

AND WHEREAS, as per decision of NRC taken in its 220th Meeting, Show Cause Notice was issued to the institution on 06.06.2015 on the following grounds:-

- The deficiencies were communicated to the institution by NRC, vide letter dated 13.07.2013 with the direction to submit the reply of deficiencies within 60 days from the date of deficiency letter. The institution has not submitted its reply to the office of NRC.

AND WHEREAS, the institution has not submitted its reply. The matter was carefully considered by NRC in its 241st Meeting held on 03rd to 07th August, 2015 and NRC refused the recognition on the following grounds:-

- The institution did not submit reply of Show Cause Notice.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Jeewan Jyoti College of Education for Women, Plot/Khasara No.- 477, Street Number- 0, Village- Faridpur, Post Office- Sikandrabad, Tehsil/Taluka- Sikandrabad, Town/City- Sikandrabad, District- Bulandshahr, Pin Code- 203205, State- Uttar Pradesh for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.

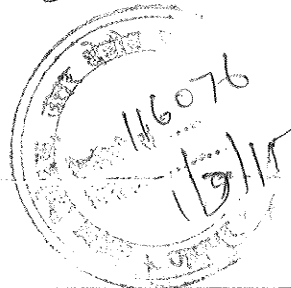
