REFUSAL ORDER

Date: 14 AUG 2015

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Ram Devi Memorial Educational Trust, Plot Number -346, Street /Road- Ramghat Road, Village/Town/City-Kidhara, Post Office – Harduaganj, Tehsil/Taluka- Koil, Town/City- Aligarh, District – Aligarh, State – Uttar Pradesh, Pin Code –202001 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Wisdom College of Elementary Education, Plot / Khasra Number -346, Street Number-NA, Village- Kidhara, Post Office – Harduaganj, Tehsil/Taluka- Koil, Town/City- Aligarh, District – Aligarh, State – Uttar Pradesh, Pin Code –202001 for D.El.Ed. Course of two year for an intake of 50 seats students on 30.12.2012.

AND WHEREAS, The matter was considered by NRC in its 20th meeting and as per decision taken by NRC the Show Cause Notice dated 19.11.2013 was issued to the institution on the following grounds:-

- The deficiencies were communicated to the institution by NRC, vide letter dated 18.04.2013 with the direction to submitted the reply of deficiencies within 60 days from the date of deficiency letter. The institution has not submitted its reply to the office of NRC.

AND WHEREAS, The matter was considered by NRC in its 221st Meeting and as per decision taken by NRC the Show Cause Notice dated 22.01.2014 was issued to the institution on the following grounds:-

- The institution has submitted two applications ID No. NRCAPP-6855, & NRCAPP-6893, the name and address of these institutions are same. As per provisions of clause 8(2) of NCTE Regulations, 2009, in the first instance an institution shall be considered to grant of recognition of only one course for a basic unit as prescribed in the norms and standards for the particular teacher programme. Therefore, more than one application submitted by the institution cannot be considered at the same time.

AND WHEREAS, The matter was considered by NRC in its 235th Meeting and as per decision taken by NRC the Show Cause Notice dated 28.05.2015 was issued to the institution on the following grounds:-

- Remaining amount of Reserve Fund (Rs. 7.00 Lakh) I.E. Rs. 4.00 Lakh is required to be submitted as per provisions of NCTE Regulations, 2014.
- The institution has not submitted approved building plan in original. The original building plan approved by competent authority indicating name of Institution, name of the course, Khasra No./Plot No. of land, total land area & built up area, size of multipurpose hall, class rooms, library ,different resource centre etc as per NCTE norms for the proposed course is required to be submitted.
- Copy of change of land use certificate issued by the competent authority under clause 143 of UP land Act is not notarized.
- No Objection Certificate from affiliating university/body has not been submitted by the institution.
- The specific information of land/building, demarcated area as per the NCTE Regulations, 2014 and information related to resolution of the society for opening the said course not for profit etc. has not given by the institution, hence, the same is required from the institution in the affidavit (format of the affidavit is enclosed herewith).

AND WHEREAS, the institution has not submitted its reply. The matter was carefully considered by NRC in its 241st Meeting held on 03rd to 07th August, 2015 and NRC refused the recognition on the following grounds:-

- Institution has not submitted reply of Show Cause Notice.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Wisdom College of Elementary Education, Plot / Khasra Number -346, Street Number-NA, Village- Kidhara, Post Office – Harduaganj, Tehsil/Taluka- Koil, Town/City- Aligarh, District – Aligarh, State – Uttar Pradesh, Pin Code – 202001 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the “online mode” available on NCTE’s website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
