**REFUSAL ORDER**

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993, the Society namely, Lala Ganesh Prasad Verma Balika Vidyalaya Samiti, Plot No.-1119,1120, Street No.-NH-56, Sultanpur Road, Village/Town/city-Salempur Ganga Ganj, Post office-Salempur, Tehsil/Taluka-Mohanlal Ganj. District-Lucknow-226501, State-Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/seeking permission to the institution i.e. Surjan Devi Anusuiya Devi Degree College, Plot No.-1119,1120, Street No.-NH-56, Village-Salempur Ganga Ganj, Post office-Salempur, Tehsil/Taluka-Mohanlal Ganj. District-Lucknow-226501, State-Uttar Pradesh for B.Ed. Course in the office of NRC on 04.01.2013.

AND WHEREAS, a deficiency letter was issued to the institution on 08.08.2013. The reply was considered by NRC in its 221<sup>st</sup> meeting held from 15<sup>th</sup> to 17<sup>th</sup> November, 2013 and NRC decided that VT be constituted. The inspection of the institution was conducted u/s 14 on 30.01.2014.

AND WHEREAS, the reply was considered by the NRC in its 225<sup>th</sup> Meeting held from 25<sup>th</sup> February to 01<sup>st</sup> March, 2014 and NRC decided to issue letter of intent under clause 7(13) of NCTE Regulations, 2014 prior to grant of formal recognition. Accordingly, a letter of intent was issued to the institution on 19.01.2015.

AND WHEREAS, the reply of a letter of intent dated 19.01.2015 has not been received in NRC office till date. The matter was considered by NRC in its 238<sup>th</sup> Meeting (Part-VI) held from May 20-31, 2015 and it was decided to issue show cause notice. Accordingly, Show Cause Notice was issued to the institution on 04.06.2015 on the following points:-

- The institution has not submitted reply of letter of intent.

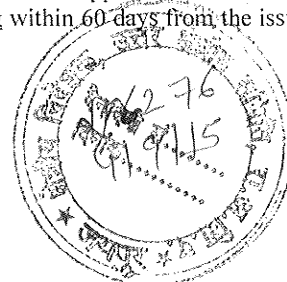
AND WHEREAS, the reply of a Show Cause Notice dated 04.06.2015 has not been received in NRC office till date. The matter was considered by NRC in its 241<sup>st</sup> Meeting held from 03<sup>rd</sup> to 07<sup>th</sup> August, 2015. The NRC after considering the matter in detail observed/decided the following: -


- No reply of SCN submitted by the institution after LOI.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refused the recognition to the institution i.e. Surjan Devi Anusuiya Devi Degree College, Plot No.-1119,1120, Street No.-NH-56, Village-Salempur Ganga Ganj, Post office-Salempur, Tehsil/Taluka-Mohanlal Ganj. District-Lucknow-226501, State-Uttar Pradesh for B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the issue of this order. The guidelines of appeal are enclosed herewith.




