**REFUSAL ORDER**

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Haree Krishna Education Foundation, Plot Number – 2700, Street/Road– 1, Village/Town/City- Sarsaul, Post Office– Sarsaul, Tehsil/Taluka- Kanpur Nagar, Town/City- Kanpur Nagar, District– Kanpur Nagar (UP), State – Uttar Pradesh, Pin Code – 209402 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Radha Gopal Girls Degree College, Plot Number – 2700, Street/Road– 1, Village/Town/City- Sarsaul, Post Office– Sarsaul, Tehsil/Taluka- Kanpur Nagar, Town/City- Kanpur Nagar, District– Kanpur Nagar (UP), State – Uttar Pradesh, Pin Code – 209402 for B.Ed. Course of one year for an intake of 100 seats students on 29.12.2012.

- Institution has refused for inspection.



The matter was considered by NRC in its 241<sup>st</sup> Meeting held on 03<sup>rd</sup> to 07<sup>th</sup> August, 2015 and it was decided that the application of the institution be refused on the following grounds:

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Radha Gopal Girls Degree College, Plot Number – 2700, Street/Road– 1, Village/Town/City- Sarsaul, Post Office– Sarsaul, Tehsil/Taluka- Kanpur Nagar, Town/City- Kanpur Nagar, District– Kanpur Nagar (UP), State – Uttar Pradesh, Pin Code – 209402 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the “online mode” available on NCTE’s website [www.ncte.india.org](http://www.ncte.india.org) within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
