Refusal Order

AND WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993 Dr. D.C. Shastri Shiksha Sansthan, Plot Number- 356, 358, Street/Road-Delhi Road, Village/Town/City- Kashi, Post Office- Mohiddinpur, Tehsil/Taluka- Meerut, Town/City- Meerut, District- Meerut, State- UP, Pin Code- 250001, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Institute of Professional Studies, Plot/Khasra Number- 356, 358, Street Number- NA, Village- Kashi, Post Office- Mohiuddinpur, Tehsil/Taluka- Meerut, Town/City- Meerut, District- Meerut (UP), State- UP, Pin Code- 250001, for B.Ed. Course of one year duration for an intake of 100 seats students on 31.12.2012.

AND WHEREAS, the Northern Regional Committee, National Council for Teacher Education in its 234th Meeting considered the case and NRC decided to issue a Show Cause Notice under clause 14/15 (3) (b) of the NCTE Act 1993. Accordingly, Show Cause Notice was issued to the institution on 16.06.2015 on the following grounds.

- Original FDRs of Rs. Five lakh and Rs. Seven Lakh of Nationalized bank towards endowment fund and reserve fund was not submitted respectively as per NCTE Regulation, 2014.
- As per building plan submitted by the institution, name of the proposed course is not mentioned in the building plan.
- No Objection Certificate from affiliating university / body has not been submitted by the institution.
- The specific information land / building, demarcated area as per the NCTE Regulations, 2014 and information related to resolution of the society for opening the said course not for profit etc. has not given by the institution, hence, the same is required from the institution in the affidavit (format of the affidavit is enclosed herewith).

AND WHEREAS, the matter was considered by NRC in its 241st Meeting held from 3rd to 7th August, 2015 and it was decided that the application of the institution be refused on the following grounds :


- The institution did not submit reply of Show Cause Notice.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby refused the above application of the institution i.e. Institute of Professional Studies, Plot/Khasra Number- 356, 358, Street Number- NA, Village- Kashi, Post Office- Mohiuddinpur, Tehsil/Taluka- Meerut, Town/City- Meerut, District- Meerut (UP), State- UP, Pin Code- 250001, for 100 seats in the B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order.
