**REFUSAL ORDER**

WHEREAS, in terms of Section 14/15 of the NCTE Act, Sparsh Jan Sewa Trust, Plot Number- 34a/34b, Street/Road- Bhai Bhadar Road, Village/Town/City- Sakra Ram Nagar, Post Office- Ram Nagar, Tehsil/Taluka- Amethi, Town/City- NA, District- Sultanpur (UP), Pin Code- 227405, State- Uttar Pradesh had applied in the office of NRC for seeking recognition for conducting B.Ed. Course of on year duration with an annual intake of 100 (One Hundred Only) Students on 30.01.2013 (Speed Post dated 31.12.2012) in the proposed Institution i.e. Sparsh Mahavidyalaya, Plot/Khasara No.- 34a/ 34b, Street Number- NA, Village- Sakra Ram Nagar, Post Office- Ram Nagar, Tehsil/Taluka- Amethi, Town/City- NA, District- Sultanpur, Pin Code- 227405, State- Uttar Pradesh.

AND WHEREAS, The inspection of the institution was conducted on 30.09.2013. The VTR of the institution was considered by NRC in 221<sup>st</sup> Meeting and as per decision of NRC, letter of intent under clause 7(9) of NCTE Regulations, 2009 dated 20.12.2013 was issued to the institution.

AND WHEREAS The institution has not submitted its reply of letter of intent. The matter was considered by NRC in 232<sup>nd</sup> Meeting (2<sup>nd</sup> Sitting) and as per decision of NRC, Show Cause Notice dated 26.03.2015 was issued to the institution on the following grounds:

- o Institution was given 7/9 (7/13) LOI, vide letter No NCTE/NRCAPP-6768/221<sup>st</sup> Meeting/67240-241 dated 20.12.2013. The institution has been submitted faculty duly approved by affiliating body.
- o FDRs of Rs 5 Lac an endowment fund & Rs. 3 Lac + 4 Lac towards reserved fund in Joint account and print out copy of hyper link web page.

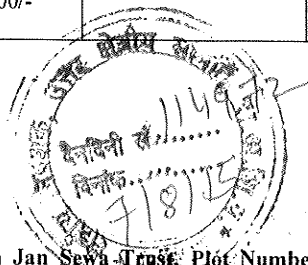
AND WHEREAS, The institution has not submitted its reply of the Show Cause Notice. The matter was again considered by NRC in its 239<sup>th</sup> Meeting and NRC decided to refuse the application of the institution on the following grounds:


- o Not submitted reply of SCN given on 26.03.2015. Application of B.Ed. is rejected.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Sparsh Mahavidyalaya, Plot/Khasara No.- 34a/ 34b, Street Number- NA, Village- Sakra Ram Nagar, Post Office- Ram Nagar, Tehsil/Taluka- Amethi, Town/City- NA, District- Sultanpur, Pin Code- 227405, State- Uttar Pradesh for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte.india.org](http://www.ncte.india.org) within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
