REFUSAL ORDER

M'4 AUG 2015

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Mukundi Devi Kamla Yadav Ucch Shiksha Sansthan, Plot Number-Kamalpur, Street/Road- Kamalpur, Village/Town/City- Kamalpur, Post Office- Kamalpur, Tehsil/Taluka- Bah, Town/City- Bah, District-Agra(UP), State- UP, Pin Code- 201001 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Sant Narayan Das College, Plot/Khasra Number- 218, Street Number- 0, Village- Kamalpur, Post Office- Kamalpur, Tehsil/Taluka- Bah, Town/City- Bah, District- Agra(UP), State- Uttar Pradesh, Pin Code- 201001 for B.Ed. Course of one year for an intake of 100 seats students on 31.12.2012.

AND WHEREAS, After scrutiny the matter was considered by the NRC in its 217th Meeting and as per decision taken by NRC the Show Cause Notice issued to the institution on 29.10.2013 on the following grounds:-

• The institution has not submitted the hard copy in time.

AND WHEREAS, The matter was carefully considered by the NRC in its 222nd Meeting as per the provision of NCTE Regulations, 2009, and it was decided by the Northern Regional Committee that application be processed and the Deficiency letter be issued:-

- The institute has submitted only one set of hard copy of on line application instead of three sets.
- Original FDRs of Rs. Five Lakh and Three Lakh of nationalized bank towards Endowment fund and Reserved Fund respectively has not submitted.
- Certified copy of registered land documents issued by the competent authority (office of Registrar/ Sub Registrar) as required under provision of NCTE regulation, 2009 has not submitted.
- The institution has not submitted approved building plan in original. The original building plan approved by competent authority indicating name of Institution, name of the course, Khasra No./Plot No. of land, total land area & built up area, size of multipurpose hall, class rooms, library, different resource centre etc as per NCTE norms for the proposed course is required to be submitted.
- Notarized copy of change of land use certificate issued under clause 143 of UP land Act by the competent authority has not submitted.
- The DD No. 467983 dated 28.12.2012 is enclosed herewith is original which to be submitted by the institution after revalidation.
- The specific information of land/ building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hence the same is required from the institution in the affidavit(format of the affidavit is enclosed herewith).

AND WHEREAS, As per decision of NRC taken in its 238th Meeting (Part-II), Show Cause Notice was issued to the institution on 17.06.2015 on the following grounds:-

Institution has not submitted the reply of the deficiency letter of NRC dated 28.01.2014.

AND WHEREAS, the institution has not submitted its reply. The matter was carefully considered by NRC in its 241^{st} Meeting held on 03^{rd} to 07^{th} August, 2015 and NRC refused the recognition on the following grounds:-

• The institution did not submit reply of Show Cause Notice.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Sant Narayan Das College, Plot/Khasra Number- 218, Street Number- 0, Village- Kamalpur, Post Office- Kamalpur, Tehsil/Taluka- Bah, Town/City- Bah, District- Agra(UP), State- Uttar Pradesh, Pin Code- 201001 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
