Refusal Order

AND WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993 Hindu Shiksha Sansthan, Plot Number- 112, Street/Road-Saharanpur Road, Village/Town/City- Majhari, Post Office- Kamboh Mazara, Tehsil/Taluka- Behat, Town/City- Saharanpur, District- Saharanpur, State- UP, Pin Code- 247121, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Premvati College of Education, Plot Number - 112, Street / Road - 0, Village - Majhari, Post Office- Kamboh Mazara, Tehsil/Taluka- Behat, Town/City- Saharanpur, District- Saharanpur, State- UP, Pin Code- 247121, for B.Ed. Course of one year duration for an intake of 100 seats students on 31.12.2012.

AND WHEREAS, the Northern Regional Committee, National Council for Teacher Education in its 234th Meeting considered the case and NRC decided to issue a Show Cause Notice under clause 14/15 (3) (b) of the NCTE Act 1993. Accordingly, Show Cause Notice was issued to the institution on 28.05.2015 on the following grounds.

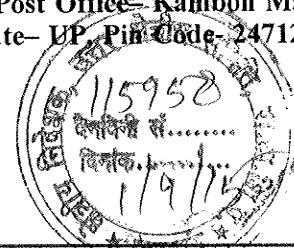
- The institute has submitted only two set of hard copy of online application instead of three sets.
- Original FDRs of Rs. Five lakh and Rs. Seven Lakh of Nationalized bank towards endowment fund and reserve fund respectively has not submitted as per provisions of NCTE Regulations, 2014.
- Certified copy of registered land documents issued by the competent authority (office of Registrar / Sub-registrar) as required under provision of NCTE Regulations, 2014 has not submitted.
- The institution has not submitted approved building plan in original. The original building plan approved by the Competent Authority indicating name of the institution, name of the course, khasra/plot no. of land, total land area & built-up area, size of multipurpose hall, classrooms, library, different resource centre etc. as per NCTE Norms for the proposed course is required to be submitted.
- Notarized copy of change of land use certificate issued under clause 143 of UP Land Act by the competent authority has not submitted.
- Point 5 of the Affidavit is incomplete.
- Date of registration of land document is not mention in the affidavit.
- No Objection Certificate from affiliating university / body has not been submitted by the institution.
- The specific information land / building, demarcated area as per the NCTE Regulations, 2014 and information related to resolution of the society for opening the said course not for profit etc. has not given by the institution, hence, the same is required from the institution in the affidavit (format of the affidavit is enclosed herewith).

AND WHEREAS, the matter was considered by NRC in its 241st Meeting held from 3rd to 7th August, 2015 and it was decided that the application of the institution be refused on the following grounds :

- The institution did not submit reply of Show Cause Notice.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby refused the above application of the institution i.e. Premvati College of Education, Plot Number - 112, Street / Road - 0, Village - Majhari, Post Office- Kamboh Mazara, Tehsil/Taluka- Behat, Town/City- Saharanpur, District- Saharanpur, State- UP, Pin Code- 247121, for 100 seats in the B.Ed. course on the grounds mentioned above.


