REFUSAL ORDER

WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993, Pt. Purusottam Degree College Samiti Plot No-83,84,85,9, Street/ Road-Mahila, Vill-Dhana, Post Office- Mahila, Teh/Taluk-Manjhanpur, Town/City- Kaushambi, Dist- Kaushambi, (UP), State-UP, Pin-212216 had submitted an application to the Northern Regional Committee of NCTE on 24.12.2012 for grant of recognition / permission to the institution i.e. Pt Purusottam Degree College Plot/Khasara No-83,84,85&91, Plot No.83,84,85&91, Street Number-Mahila, Vill-Dhana, Post Office-Mahila, Teh/Taluk- Manjhanpur, Town/City- Kaushambi, Dist- Kaushambi, (UP), State-UP, Pin-212216 for B.Ed. Course of two year duration for an intake of 100 students, for academic session 2013-14.

AND WHEREAS, a deficiency letter was issued to the institution on 08.06.2013 to the institution. The reply of the deficiency letter was submitted on 08.08.2013 by the institution.

AND WHEREAS, the reply was considered by NRC in its 220th Meeting held from October 25th to 29th, 2013 and NRC decided that VT be constituted. The inspection of the institution was conducted on 07.01.2014.

AND WHEREAS, the VTR was placed before the NRC in its 232nd (1st Sitting) held from 02th to 06th February, 2015. The Committee decided to issue letter of intent under clause 7(13) of NCTE Regulations, 2014 for B.Ed. course prior to grant of recognition. Accordingly, a letter of intent under clause 7(13) was issued to the institution on 23.02.2015.

AND WHEREAS, the reply of a letter of intent has not been received in NRC office till date. The matter was considered by the NRC in its 238th (VI- Sitting) meeting held from 20-31 May, 2015 and it was decided to issue show cause notice. Accordingly, show cause notice was issue to the institution on the following point:

- The institution has not submitted reply of letter of intent.

AND WHEREAS, a show cause notice was issued to the institution on 04.05.2015.


AND, WHEREAS, the reply was considered by NRC in its 240th meeting held from 20th to 22nd July, 2015 and the NRC decided that recognition/permission to the institution is refused u/s 14/15 (3)(b) of the NCTE Act, 1993 on the following point:

- The institution has not submitted reply of SCN.

NOW, THEREFORE, in exercise of the powers vested under section 14/15 (3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby refused the recognition to the institution i.e. Pt Purusottam Degree College Plot/Khasara No-83,84,85&91, Plot No.83,84,85&91, Street Number-Mahila, Vill-Dhana, Post Office- Mahila, Teh/Taluk- Manjhanpur, Town/City- Kaushambi, Dist-Kaushambi, (UP), State-UP, Pin-212216 on the grounds mentioned above. The original FDRs submitted by the institution are returned herewith.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order. The guidelines for filing of appeal are available on NCTE website.
