**REFUSAL ORDER**

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993, the Society namely, **Brij Bihari Dubey Educational Trust, Street No.-Near Bhagat Chauraha, Village-Kajakpur, Post office-Taramandal, Tehsil/Taluka-Sadar, Town/City-Gorakhpur, District-Gorakhpur-273001, State-Uttar Pradesh** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/seeking permission to the institution i.e. **Saraswati Devi Mahila Mahavidyalaya, Plot No.-137, Village-Tikulahiya, Post office-Nichlaul, Tehsil/Taluka-Nichalul, Town/City-Nichlaul, District-Maharajganj-273304, State-Uttar Pradesh** for B.Ed. Course in the office of NRC on **03.01.2013**.

AND WHEREAS, a deficiency letter was issued to the institution on 16.04.2013. The reply was considered by NRC in its 219<sup>th</sup> meeting held from 26<sup>th</sup> to 29<sup>th</sup> September, 2013 and it was decided to issue show cause notice. Accordingly, Show Cause Notice was issued to the institution on 18.10.2013 on the following points:-

- *Certified copies of the registered land documents in respect of plot no. as mentioned in the application duly registered in the office of Registrar / Sub - Registrar has not been submitted.*
- *Institution has not submitted original duly approved Building Plan from the Competent Authority.*

AND WHEREAS the reply was considered by NRC in its 222<sup>nd</sup> meeting held from December 24<sup>th</sup> to 28<sup>th</sup>, 2013 and NRC decided that VT be constituted. The inspection of the institution was conducted u/s 14 on 07.03.2014.

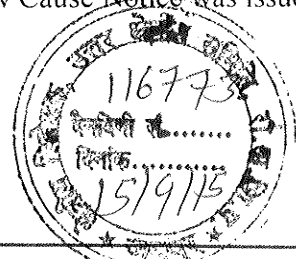
AND WHEREAS, the VTR was considered by the NRC in its 231<sup>st</sup> meeting held from 21-24 January, 2015 and the Committee was decided that:-

*The institution be asked to submit the un-edited video recording (CD) of the visit of the inspection team to the institution for further action in the case.*

AND WHEREAS, the reply was considered by NRC in its 233<sup>rd</sup> meeting (Part-I) held on February 2015 and NRC decided to issue letter of intent under clause 7(13) of NCTE Regulations, 2014 prior to grant of formal recognition. Accordingly, a letter of intent was issued to the institution on 25.02.2015.

AND WHEREAS, the reply of a letter of intent dated 25.02.02.2015 has not been received in NRC office till date. The matter was considered by NRC in its 238<sup>th</sup> Meeting (Part-VI) held from May 20-31, 2015 and it was decided to issue show cause notice. Accordingly, Show Cause Notice was issued to the institution on 04.06.2015 on the following points:-

- *The institution has not submitted reply of letter of intent.*




AND WHEREAS, the reply of a Show Cause Notice dated 04.06.2015 has not been received in NRC office till date. The matter was considered by NRC in its 241<sup>st</sup> Meeting held from 03<sup>rd</sup> to 07<sup>th</sup> August, 2015. The NRC after considering the matter in detail observed/decided the following: -

- *No reply of SCN submitted by the institution after LOI.*

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refused the recognition to the institution i.e. **Saraswati Devi Mahila Mahavidyalaya, Plot No.-137, Village-Tikulahiya, Post office-Nichloul, Tehsil/Taluka-Nichalul, Town/City-Nichloul, District-Maharajganj-273304, State-Uttar Pradesh** for B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the issue of this order. The guidelines of appeal are enclosed herewith.
