REFUSAL ORDER

Date: 17 SEP 2015

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Samajwadi Siksha Sansthan, Plot No.- 31 K, Street/Road- 80 Feet Road, Yashoda Naga, Village/Town/City- Kanpur Nagar, Post Office- Kanpur Nagar, Tehsil/Taluka- Kanpur Nagar, Town/City- Kanpur Nagar, District- Kanpur Nagar, State- U.P., Pin Code- 208011 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Mulayam Singh Mahavidyalaya, Plot No.- 1941, 1942K, Street/Road- Kathara, Village- Kathara, Post Office- Kathara, Tehsil/Taluka- Kanpur Nagar, Town/City- Kanpur Nagar, District- Kanpur Nagar, State- U.P., Pin Code- 209214 for D.El.Ed. Course of two years for an intake of 50 seats students on 31.12.2012.

AND WHEREAS, as per decision of NRC taken in its 239th Meeting, Show Cause Notice was issued to the institution on 13.07.2015 on the following grounds:-

- The institution refused for inspection.

AND WHEREAS, the institution has not submitted its reply. The matter was carefully considered by NRC in its 242nd Meeting held on 01st to 03rd September, 2015 and NRC refused the recognition on the following grounds:-

- The institution has not submitted reply of Show Cause Notice issued on 13.07.2015.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Mulayam Singh Mahavidyalaya, Plot No.- 1941, 1942K, Street/Road- Kathara, Village- Kathara, Post Office- Kathara, Tehsil/Taluka- Kanpur Nagar, Town/City- Kanpur Nagar, District- Kanpur Nagar, State- U.P., Pin Code- 209214 for the D.El.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.

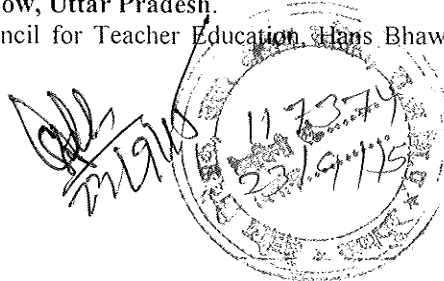
