REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Shree Ganapati Charitable and Welfare Trust, Plot Number- B-118/2, Street/Road- Garh Road, Village/Town/City- Takshila Colony, Post Office- Medical College, Tehsil/Taluka- Meerut, Town/City- Meerut, District- Meerut (UP), State- UP, Pin Code- 250004 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Ganga Girls Education College, Plot Number- 357, Street/Road- Nh-24, Village- Bhagwanpur Khaddar, Post Office- Gajraula, Tehsil/Taluka- Hasanpur, Town/City- Gajraula, District- Jyotiba Phule Nagar (UP), State- UP, Pin Code- 244235 for B.Ed. Course of one year for an intake of 100 seats students on 31.12.2012.

- The institution refused for inspection.




- The institution has not submitted reply of Show Cause Notice dated 20.08.2013 issued by NRC, NCTE, Jaipur.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Ganga Girls Education College, Plot Number- 357, Street/Road- NH-24, Village- Bhagwanpur Khaddar, Post Office- Gajraula, Tehsil/Taluka- Hasanpur, Town/City- Gajraula, District- Jyotiba Phule Nagar (UP), State- UP, Pin Code- 244235 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
