REFUSAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, SMT Premvati Sewa Nidhi Trust, Plot Number- 2231/2, Street/Road- Delhi Road, Village/Town/City- Shivaji Nagar, Post Office- Saharanpur, Tehsil/Taluka- Saharanpur, Town/City- Saharanpur, District- Saharanpur (UP), State- UP, Pin Code- 247001 had applied in the office of NRC for seeking recognition for conducting B.Ed. Course of on year duration with an annual intake of 100 (One Hundred Only) Students on 07.01.2013 in the proposed Institution i.e. Krishna College, Plot/Khasra Number- 132/10,132/11,132/3,132/2,132/12, Street/Road- 0, Village- Ugrahu Ahtamal, Post Office- Gagalheri, Tehsil/Taluka- Saharanpur, Town/City- Gagalheri, District- Sharanpur (UP), State- UP, Pin Code- 247001.

AND WHEREAS, The inspection of the institution was conducted on 30.12.2013. The VTR of the institution was considered by NRC in 224th Meeting and as per decision of NRC, letter of intent under clause 7(9) of NCTE Regulations, 2009 dated 25.02.2014 was issued to the institution.

AND WHEREAS The institution has not submitted its reply of letter of intent. The matter was considered by NRC in 232nd Meeting (2nd Sitting) and as per decision of NRC, Show Cause Notice dated 27.03.2015 was issued to the institution on the following grounds:

- o The institute has not submitted faculty duly approved by the affiliating body.
- o Joint FDRs is not submitted
- o Down loaded copies of website.

AND WHEREAS, The institution has not submitted its reply of the Show Cause Notice. The matter was again considered by NRC in its 239th Meeting and NRC decided to refuse the application of the institution on the following grounds:

- o Reply of SCN dated 27.03.2015 is not submitted.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Krishna College, Plot/Khasra Number- 132/10,132/11,132/3,132/2,132/12, Street/Road- 0, Village- Ugrahu Ahtamal, Post Office- Gagalheri, Tehsil/Taluka- Saharanpur, Town/City- Gagalheri, District- Sharanpur (UP), State- UP, Pin Code- 247001 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
