REFUSAL ORDER

10 SEP 2015

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Shree Ganpati Charitable & Welfare Trust, Plot Number- 136, Street/Road- Garh Road, Village/Town/City- Nanpur, Post Office- Nanpur, Tehsil/Taluka- Garhmukteshwer, Town/City- Hapur, District- Ghaziabad(UP), State- UP, Pin Code- 245205 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Guru Nanak Education Degree College, Plot/Khasra Number- 1048, Street Number- Highway, Village- Aurangabad, Post Office- Aurangabad, Tehsil/Taluka- Aurangabad, Town/City- Aurangabad, District- Bulandshahr(UP), State- Uttar Pradesh, Pin Code- 2245401 for B.Ed. - The institution refused for inspection.





- The institution has not submitted reply of Show Cause Notice dated 20.08.2013 issued by NRC, NCTE, Jaipur.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Guru Nanak Education Degree College, Plot/Khasra Number- 1048, Street Number- Highway, Village- Aurangabad, Post Office- Aurangabad, Tehsil/Taluka- Aurangabad, Town/City- Aurangabad, District- Bulandshahr(UP), State- Uttar Pradesh, Pin Code- 2245401 for the B.Ed. Course on the grounds mentioned above.
