REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Janhit Charitable Trust, Plot Number- SH.-299, Street /Road-N/A, Village/Town/City- Shastri Nagar, Post Office - Kavi Nagar, Tehsil/Taluka- Ghaziabad, Town/City- Ghaziabad, District- Ghaziabad (UP), State - Uttar Pradesh, Pin Code -201001 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Sir Choutu Ram College of Education, Plot / Khasra Number-130, Street Number- N/A, Village- Gangali, Post Office- Chhutmalpur, Tehsil/Taluka- Saharanpur, Town/City- Saharanpur, District-Saharanpur (UP), State - Uttar Pradesh, Pin Code -247662 for B.Ed. Course of one year for an intake of 100 seats students on 31.12.2012.

AND WHEREAS, as per decision of NRC taken in its 232nd (2nd Sitting) Meeting, Show Cause Notice was issued to the institution on 26.03.2015 on the following grounds:-

- Reply of Letter of intent under Section 7 (13) of NCTE Regulations, 2014 / 7(9) of NCTE Regulations, 2009 has not been submitted.

AND WHEREAS, the institution has not submitted its reply. The matter was carefully considered by NRC in its 242nd Meeting held on 01st to 03rd September, 2015 and NRC refused the recognition on the following grounds:-

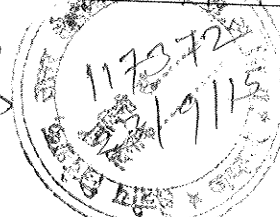
- The institution has not submitted reply of Show Cause Notice dated 13.07.2013 issued by NRC, NCTE, Jaipur.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Sir Choutu Ram College of Education, Plot / Khasra Number-130, Street Number- N/A, Village- Gangali, Post Office- Chhutmalpur, Tehsil/Taluka- Saharanpur, Town/City- Saharanpur, District-Saharanpur (UP), State - Uttar Pradesh, Pin Code -247662 for the B.Ed. Course on the grounds mentioned above.


