**REFUSAL ORDER**

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Shree Mahavir Singh Gyan Trust Mainpuri, Plot Number- 2886, Street/Road- Moh Kharangeet Nagar, Village/Town/City- Mainpuri, Post Office- Mainpuri, Tehsil/Taluka- Mainpuri, Town/City- Mainpuri, District- Mainpuri, State - Uttar Pradesh, Pin Code - 20500 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Ch. Mahaveer Singh Mahavidyalaya, Plot / Khasra Number- 483/91, Street Number- Dalupur Road, Village- Nagla Shobha, Post Office- Dalupur, Tehsil/Taluka- Karhal, Town/City- Barnhal, District - Mainpuri, State- Uttar Pradesh, Pin Code- 205261 for D.El.Ed. Course of two years for an intake of 50 seats students on 30.12.2012.

AND WHEREAS, As per decision of NRC taken in its 231<sup>st</sup> meeting, Show Cause Notice was issued to the institution on 20.07.2015 on the following grounds:

- A copy of approved building plan having demarcated built up area for proposed D.El.Ed. course, existing B.Ed. course and other educational course being conducted by institution at khasra no. 483/91 is required to be submitted.
- Legible notarized copy of change of land use (CLU) certificate issued by SDM under section 143 of UP land act is required.
- The information at S. No. 3 & 5 of the Affidavit is not filled up properly.
- The institution has submitted print out of the online application form, which is not valid print out of the application form. Hence valid print out of the application is required.
- Both FDR i.e. lakes and 7 lakes in the favour of President of Society. Hence the institution is required to submit both FDRs in the favour of Institution/Society.
- The institution is required to submit NOC from Affiliating Body.
- The institution is required to submitted the evidence to establish that the institution is a composite institution.
- The institution is required to submit an Affidavit of Rs. 100/- stamp paper as per the format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (ii) of the NCTE Regulations 2014 & page 4 & 5 of the online application form.

AND WHEREAS, The institution has not submitted its reply of the Show Cause Notice. The matter was considered by NRC in its 242<sup>nd</sup> Meeting held on 01<sup>st</sup> to 03<sup>rd</sup> September, 2015 and it was decided that the application of the institution be refused on the following grounds:

- The Show Cause Notice was issued to the institution on 20.07.2015. The reply submitted by the institution was considered and found that the institution has not submitted NOC from affiliating body and evidence with regard to composite institution.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Ch. Mahaveer Singh Mahavidyalaya, Plot / Khasra Number- 483/91, Street Number- Dalupur Road, Village- Nagla Shobha, Post Office- Dalupur, Tehsil/Taluka- Karhal, Town/City- Barnhal, District - Mainpuri, State- Uttar Pradesh, Pin Code- 205261 for the D.El.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte.org](http://www.ncte.org) within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
