REFUSAL ORDER

11.09.2015

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Shree Ganpat Charitable and Welfare Trust, Plot Number- B-118/2, Street/Road- Garh Road, Village/Town/City- Takshila Colony, Post Office- Medical College, Tehsil/Taluka- Meerut, Town/City- Meerut, District- Meerut (UP), State- UP, Pin Code- 250004 has submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. SD Girls Education College, Plot/Khasra Number- 250, 260, Street Number- Nh-24, Village- Khungawali, Post Office- Gajraula, Tehsil/Taluka- Hasanpur, Town/City- Gajraula, District- Jyotiba Phule Nagar (UP), State- UP, Pin Code- 244235 for B.Ed. - The institution refused for inspection.

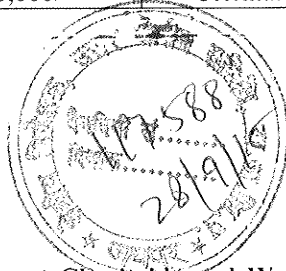
AND WHEREAS, the institution has not submitted its reply. The matter was carefully considered by NRC in its 242nd Meeting held on 01st to 03rd September, 2015 and NRC refused the recognition on the following grounds:-

- The institution has not submitted reply of Show Cause Notice dated 13.07.2015.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. SD Girls Education College, Plot/Khasra Number- 250, 260, Street Number- Nh-24, Village- Khungawali, Post Office- Gajraula, Tehsil/Taluka- Hasanpur, Town/City- Gajraula, District- Jyotiba Phule Nagar (UP), State- UP, Pin Code- 244235 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
