**REFUSAL ORDER**

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Smt Mahadevi Social Welfair And Educational Trust, Plot Number- 189, Street/Road- Sirsaganj Road, Village/Town/City- Sirsaganj, Post Office- Jaimai, Tehsil/Taluka- Shikohabad, Town/City- Sirsaganj, District- Firozabad(UP), State- UP, Pin Code- 205151 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Smt Mahadevi Memorial Girls College of Education, Plot/Khasra Number- 189, Street Number- Jaimai, Village- N. Ball, Post Office- Jaimai, Tehsil/Taluka- Shikohabad, Town/City- Sirsaganj, District- Firozabad(UP), State- Uttar Pradesh, Pin Code- 205151 for B.Ed. Course of one year for an intake of 100 seats students on 30.12.2012.

AND WHEREAS, As per decision of NRC taken in its 236<sup>th</sup> meeting, Show Cause Notice was issued to the institution on 20.05.2015 on the following grounds:

- The institution has not submitted reply of the deficiency letter dated 20.01.2014.

AND WHEREAS, The institution has not submitted its reply of the Show Cause Notice. The matter was considered by NRC in its 242<sup>nd</sup> Meeting held on 01<sup>st</sup> to 03<sup>rd</sup> September, 2015 and it was decided that the application of the institution be refused on the following grounds:


- The institution has not submitted reply of Show Cause Notice dated 20.05.2015.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Smt Mahadevi Memorial Girls College of Education, Plot/Khasra Number- 189, Street Number- Jaimai, Village- N. Ball, Post Office- Jaimai, Tehsil/Taluka- Shikohabad, Town/City- Sirsaganj, District- Firozabad(UP), State- Uttar Pradesh, Pin Code- 205151 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte.india.org](http://www.ncte.india.org) within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.
