REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993, Maa Umrawati Jan Sewa Trust, Plot No. 511, Village - Khajura, Post Office- Baurawa, Tehsil- Sadipur, Dist.- Ghazipur (UP) 233304 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/ permission to the institution i.e Maa Umrawati College of Education, Plot No. 511, 513, 515, 522Village - Khajura, Post Office- Baurawa, Tehsil- Sadipur, Dist.- Ghazipur (UP) 233304 for D.El.Ed. Course on 08.06.2015.

AND WHEREAS, a notice before rejection of application under clause 14/15(3)(b) of the NCTE Regulations, 2014 was issued to the institution by the NRC, NCTE on 21.09.2016 on the following points:-

- The institution has not submitted any proof / evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.

AND WHEREAS, the matter was considered by the NRC in its 260th meeting held from 21st to 23rd November, 2016 and the Committee decided that the application is rejected and recognition/permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993 on the following points. FDRs, if any, be returned to the institution.


- The institution was given show cause notice vide letter dt. 21.09.2016 with direction to submit the reply within 30 days. The institution did not submit any reply of show cause notice till date.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 2009, the Northern Regional Committee hereby refuse the recognition of the institution i.e. Maa Umrawati College of Education, Plot No. 511, 513, 515, 522Village - Khajura, Post Office- Baurawa, Tehsil- Sadipur, Dist.- Ghazipur (UP) 233304 for D.El.Ed. Course on the ground mentioned above.

If the institution is not satisfied by the above order they can prefer an appeal to the Council (NCTE, New Delhi) in terms of section 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the issue of this order. 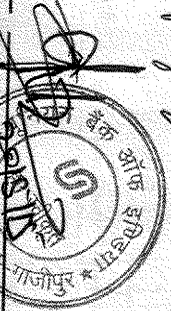
