**REFUSAL ORDER**

WHEREAS, in terms of Section 14/15 of the NCTE Act, Shree Ganpati Charitable And Welfare Trust, Plot Number- 136, Street /Road- Garh Road, Village/Town/City- Nanpur, Post Office - Nanpur, Tehsil/Taluka- Garhmukteshwer, Town/City- Hapur, District- Ghaziabad (UP), State - Uttar Pradesh, Pin Code - 245205 had applied in the office of NRC for seeking recognition for conducting B.Ed. Course of one year duration with an annual intake of 100 (One Hundred Only) Students on 07.01.2013 in the proposed Institution i.e. Savitri Devi Girls Education College, Plot / Khasra Number- 347,348, Street Number- NH-24, Village- Bhagwanpur Khaddar, Post Office- Gajraula, Tehsil/Taluka- Hasanpur, Town/City- Gajraula, District- Jyotiba Phule Nagar (UP), State - Uttar Pradesh, Pin Code - 244235.

AND WHEREAS, The inspection of the institution was conducted on 14.01.2014. The VTR of the institution was considered by NRC in its 225<sup>th</sup> Meeting and as per decision of NRC, letter of intent dated 07.03.2014 was issued to the institution.

AND WHEREAS, The Institution has not submitted the reply of the aforesaid letter. The matter was considered by NRC in its 232<sup>nd</sup> Meeting (2<sup>nd</sup> Sitting) and as per decision of NRC, Show Cause Notice dated 27.03.2015 was issued to the institution on the following points:

- o The institute has not submitted faculty duly approved by the affiliating body.
- o Down loaded copies of website.
- o Joint FDRs not submitted.


AND WHEREAS, The institution has not submitted the reply of the Show Cause Notice. The matter was carefully considered by NRC in its 239<sup>th</sup> Meeting and NRC decided to refuse the recognition of the institution on the following grounds:

- o The institution has not submitted any reply till date to the SCN issued by NRC on 27.03.2015. Hence, rejected.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Savitri Devi Girls Education College, Plot / Khasra Number- 347,348, Street Number- NH-24, Village- Bhagwanpur Khaddar, Post Office- Gajraula, Tehsil/Taluka- Hasanpur, Town/City- Gajraula, District- Jyotiba Phule Nagar (UP), State - Uttar Pradesh, Pin Code - 244235 for the B.Ed. Course on the grounds mentioned above.


