REFUSAL ORDER

12 FEB 2017

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993, Shri Mahesh Chandra Foundation, Plot no. D 5, Street -Rampur Garden, Village -Bareilly, P.O. -Civil Lines, Tehsil - Sadar, Town -Bareilly, District -Bareilly-243001 , Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Mahesh Chandra, Plot no. 907-913 & 916-922, Street -NH-24, Village -Joharpur, P.O. -C.B. Ganj, Tehsil - Sadar, Town -Bareilly, District -Bareilly-243001 , Uttar Pradesh for D.El.Ed. Course to the NRC office on 04.06.2015.

AND WHEREAS, a notice before summarily rejection of application under clause 7(1) of the NCTE Regulations, 2014 was issued to the institution by the NRC, NCTE on 17.11.2015 on the following points:-

- Failure to submit NOC of the affiliating body with the hard copy of the application.

AND WHEREAS, the matter was considered by the NRC in its 261<sup>th</sup> meeting held from 14<sup>th</sup> to 19<sup>th</sup> December, 2016 and the Committee decided that the application is rejected and recognition/permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993 on the following points. FDRs, if any, be returned to the institution.

- The institution has not submitted the NOC issued by the affiliating body in reply to show cause notice.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 2009, the Northern Regional Committee hereby refuses the recognition/permission to the institution i.e Mahesh Chandra, Plot no. 907-913 & 916-922, Street -NH-24, Village -Joharpur, P.O. -C.B. Ganj, Tehsil - Sadar, Town -Bareilly, District -Bareilly-243001 , Uttar Pradesh for D.El.Ed. course on the grounds mentioned above.

If the institution is not satisfied by the above order they can prefer an appeal to the Council (NCTE, New Delhi) in terms of section 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the issue of this order.




