REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993, Puran Education Society, Plot No.- 84/5/2, 6/1, Street/ Road- Pehowa Road, Village/ Town/ City- Josar (Jyotisar) Post Office- Jyotisar, Tehsil/ Taluka- Thanesar, Town/city- Jyotisar, District- Kurukshetra 136119, State - Haryana, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition to MA Durga Puran College of Education, Plot No. - 84/5/2, 6/1, Street/ Road- Pehowa Road, Village/ Town/ City- Josar (Jyotisar) Post Office- Jyotisar, Tehsil/ Taluka - Thanesar, Town/city - Jyotisar, District- Kurukshetra 136119, State - Haryana, for B.Ed. Course of Two years duration on 27.12.2012.

AND WHEREAS, the matter was placed before NRC in its 218th meeting held from 27th to 31st August, 2013 and the Committee decided as under:-

The original file of the Institution and along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and following observations was made:-

- *The online application was made on 27.12.2012 and the hard copy of the same is received on 31.01.2013. There is no proof that the application was dispatched within 7 days from the date of online application as required in NCTE Regulations, 2009.*

Accordingly, Show Cause Notice was issued to the institution on 08.10.2013.

AND WHEREAS, the matter was placed before NRC in its 239th meeting held from 30th June to 01st July, 2015 and the Committee decided as under: -

The original file of the Institution and along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and following observations was made: -

- *The institution did not submit reply to SCN.*

Hence, the Committee decided that recognition/permission to the institution is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.

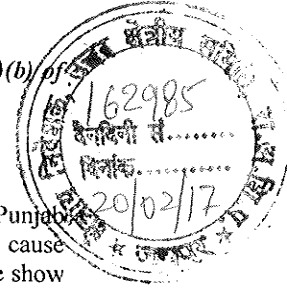
Accordingly, Refusal Order was issued to the institution on 29.07.2015.

AND WHEREAS, the institution filed a writ petition No. 22567 of 2014 in the Hon'ble High Court of Punjab & Haryana at Chandigarh with a prayer to set aside the refusal orders as he has never received the show cause notice on the basis of which the file was refused. Further, he also prayed for liberty to submit reply to the show cause notice. The Hon'ble court passed an order dated 21.07.2016 the operative portion as under:

".....In Such circumstances, petitioner has been seriously prejudiced and his application has not thus been considered on merits and in the facts and circumstances of the case, it is a case where the extra-ordinary jurisdiction is liable to be entertained. Resultantly, the order dated 29.07.2015 (Annexure P-25) declining the approval is quashed. The petitioner will be at liberty to give a detailed reply to the Show Cause Notice dated 08.10.2013 and 07.01.2015 within a period of two weeks from today and on the receipt of the said replies the respondent No. 2 will proceed in accordance with law."

AND WHEREAS, the institution submitted its reply on 28.07.2016. The matter was considered by NRC in its 262st (Part-8) meeting held from 16th to 24th January, 2017. The Committee decided to refuse recognition to the institution on the following grounds: -

- *In compliance of the order of the Hon'ble High Court of Punjab & Haryana dated 12.07.2016, the NRC considered the reply dated 22.07.2016 submitted by the applicant institution in response to the SCN issued by the NRC on 08.10.2013. The NRC observed that the reply is irrelevant as it does not contain the explanation with regard to the point mentioned in the SCN of the NRC and no proof has*

been submitted to establish that the print out (the hard copy) of the on-line application has been dispatched within the stipulated time.

Hence, the Committee decided that the application is rejected and recognition/ permission is refused w/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition permission sought by the institution i.e. MA Durga Puran College of Education, Plot No. – 84/5/2, 6/1, Street/ Road- Pehowa Road, Village/ Town/ City- Josar (Jyotisar) Post Office- Jyotisar, Tehsil/ Taluka – Thanesar, Town/city - Jyotisar, District- Kurukshetra 136119, State - Haryana, for the B.Ed. Course on the ground mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE website.
