REFUSAL/REJECTION ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Guru Nanak Education Society, Plot No - 163, Street/Road - Railway Road, Village - Firozpur, Post Office - Firozpur, Tehsil/Taluka - Firozpur, Town/City - Firozpur, Distt. -Firozpur, Pin Code - 152001, Punjab had submitted an application i.e. NRCAPP- 12944 to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Guru Nanak College, Plot No. - 163, Street/Road - Railway Road, Village - Firozpur, Post Office - Firozpur, Town/City - Firozpur, Distt. -Firozpur, Pin Code - 152001, Punjab for B.A.B.Ed, B.Sc.B.Ed Course on 30.05.2015.

AND WHEREAS, the original file of the institution along with documents was considered by the NRC in its 247th meeting held on dated. 23-29.12.2016 and the Committee decided to issue show cause notice before summarily rejection of application on the following point: -

- The Institution has submitted invalid printout of the online application.

Accordingly, the show cause notice was issued to the institution on 25.02.2016 and the institution submitted reply of show cause notice on 30.03.2016.

AND WHEREAS, the reply of show cause notice was considered by the NRC in its 251st meeting held on dated. 11-13.04.2016 and it was decided that the application of the institution be rejected and recognition/permission is refused on the following grounds: -

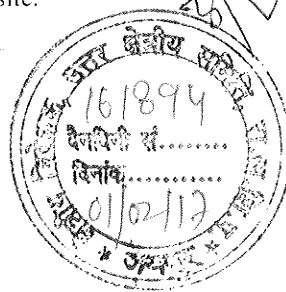
- The applicant institution has not submitted valid printout of online application is not submitted alongwith reply dated 30.03.2016
- Built up area is 2159 Sq.Mt. instead of 3500 Sq.Mt.
- No proof of processing fees of Rs. 1.50 lacks is submitted.
- The Institution has not submitted NOC from the affiliating body.
- Demarcated map is and Sale deed not certified by competent authority.
- The applicant institution has not submitted any proof / evidence that it is offering under graduate or post graduate programme of studies in the field of Liberal Arts or Humanities or Social Science or Science or Mathematics for getting grant of recognition for 4 year integrated programme leading to B.Sc. B.Ed. / B.A. B.Ed. degree as has been mentioned in Clause 2(b) of NCTE Regulations, 2014 and clause 1.1 of the Appendix 13 (Norms & Standards for B.A. B.Ed. / B.Sc. B.Ed. degree).

NOW THEREFORE, in exercise of the powers vested under Section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the said application of the institution i.e. Guru Nanak College, Plot No. - 163, Street/Road - Railway Road, Village - Firozpur, Post Office - Firozpur, Tehsil/Taluka - Firozpur, Town/City - Firozpur, Distt. -Firozpur, Pin Code - 152001, Punjab and recognition/permission is refused for B.A.B.Ed, B.Sc.B.Ed course on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE website.
