REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993 Colonel Indu Aryan Educational Charitable Trust, Plot No. - 58/2, Street/Road - Khaspur, Village - Dayalbagh, Post Office -Dayalbagh, Tehsil - Sadar Dist. - Agra, UP - 282005 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. V K Memorial College, Plot No. - 58/2, Village - Khaspur, Pot Office - Dayalbagh, Tehsil - Sadar, Dist. - Agra, UP - 282005 for B.Ed. Course to the NRC office on 27.12.2012.

AND WHEREAS, the inspection of the institution was conducted under section 14/15 of the NCTE Act, 1993 on 15.03.2014 and the VTR was received in the NRC office on 11.04.2014. The VTR was considered by the NRC in its 236th meeting held on 29-30 April and 1-2 May, 2015 and the Committee decided to issue Letter of Intent under clause 7(13) of the NCTE Regulations, 2014. Accordingly, letter of intent issued to the institution on 15.07.2015.

AND WHEREAS, the matter was considered by the NRC in its 256th (Part-2) meeting held from 22th to 25th August, 2016 and the Committee decided to issue show cause notice. the Accordingly, SCN was issued to the institution on 04.10.2016 on the following point: -

- The institution was given letter of intent under clause 7(13) of NCTE Regulation, 2014 vide letter dt. 15.07.2015. The institution did not submit any reply of letter of intent.

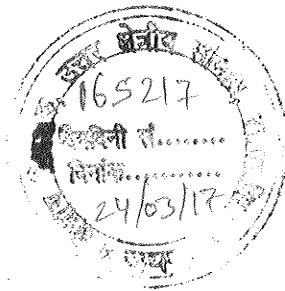
AND WHEREAS, the institution did not submit reply of show cause notice. The matter was considered by the NRC in its 263th meeting held from 06th to 11th February, 2017 and the Committee decided that the application is rejected and recognition/permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993 on the following points. FDRs, if any, be returned to the institution.

- The institution was given show cause notice. The institution did not submit reply of SCN.


NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 2009, the Northern Regional Committee hereby refuses the recognition/permission to the institution i.e V K Memorial College, Plot No. - 58/2, Village - Khaspur, Pot Office - Dayalbagh, Tehsil - Sadar, Dist. - Agra, UP - 282005 for B.Ed. course on the grounds mentioned above.




