REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993 Colonel Balwan Singh Progressive Society Plot No- 79, Street/Road- Panki Ganga Ganj, Vill- Kanpur, Post Office- Panki, Tehsil- Kanpur, Distt- Kanpur Nagar, Pin Code- 208020, UP had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. College Balwan Singh Progressive Society, Plot/Khasara No- 72C, Vill- Devpalpur, Post Office- Mallao, Tehsil- Bilhour, Distt- Kanpur Nagar, Pin Code-209203, UP. for B.Ed. Course to the NRC office on 28.12.2015.

AND WHEREAS, the reply was considered by the NRC in its 220th meeting held from 25th to 29th October, 2013 and the Committee decided that the show cause notice be issued to the institution.. Accordingly, SCN was issued to the institution on 21.11.2013 on the following point:

- The deficiencies were communicated to the Institution by NRC, vide letter dated 21.06.2013 with the direction to submit the reply of deficiencies within 60 days from the date of deficiency letter. The Institution has not submitted its reply to the office of NRC.

AND WHEREAS, the institution did not submit reply of show cause notice. The matter was considered by the NRC in its 263th meeting held from 06th to 11th February, 2017 and the Committee decided that the application is rejected and recognition/permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993 on the following points. FDRs, if any, be returned to the institution.

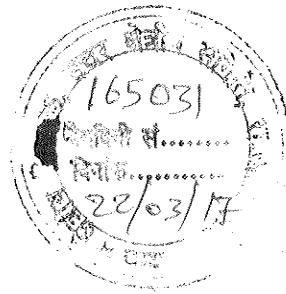
- The institution was given show cause notice. The institution did not submit reply of SCN.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 2009, the Northern Regional Committee hereby refuses recognition/permission to the institution i.e College Balwan Singh Progressive Society, Plot/Khasara No- 72C, Vill- Devpalpur, Post Office- Mallao, Tehsil- Bilhour, Distt- Kanpur Nagar, Pin Code-209203, UP. for B.Ed. course on the grounds mentioned above.

If the institution is not satisfied by the above order, it can prefer an appeal to the Council (NCTE, New Delhi) in terms of section 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the issue of this order.
