REFUSAL ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993 Colonel Sanchetana Society, Plot No. - 0, Village - Etawah, Post Office - Etawah, Dist. - Etawah, UP - 206001 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Akshara Academy, Plot No. - 58 K, Village - Eawah, Post Office - Etawah, Tehsil - Sadar, Dist. - Etawah, UP - 206000 for B.Ed. Course to the NRC office on 29.12.2015.

AND WHEREAS, the inspection of the institution was conducted under section 14/15 of the NCTE Act, 1993 on 03.01.2014 and the VTR was received in the NRC office on 15.01.2014. The VTR was considered by the NRC in its 225<sup>th</sup> meeting held from 25<sup>th</sup> February to 01<sup>st</sup> March, 2014 and the Committee decided to show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993.

- In the land documents and in the building plan the Gata No. is 58 स ; in the application form, in the Khatauni & in the Building Completion Certificate No. is 58 क and in the CLU it is both 58 स & 58 क

AND WHEREAS, the institution submitted its reply to the NRC office on 03.04.2014 in response to show cause notice. The reply was considered by the NRC in its 241<sup>st</sup> meeting held from 03<sup>rd</sup> to 07<sup>th</sup> August, 2015 and the Committee decided that the show cause notice. Accordingly, letter was issued to the institution on 21.08.2015 on the following point:

- A proof/evidence to the effect that it is a composite institution as per provisions of the NCTE Regulations, 2014
- In case the institutions which are not composite at present shall ensure that they have become composite institutions before commencement of the academic session 2016-17. An affidavit to this effect is required to be submitted by the institution to the NRC, NCTE.
- No Objection Certificate issued by the concerned affiliating body as required under clause 5(3) of the NCTE Regulations, 2014.

AND WHEREAS, the institution did not submit reply of show cause notice. The matter was considered by the NRC in its 263<sup>th</sup> meeting held from 06<sup>th</sup> to 11<sup>th</sup> February, 2017 and the Committee decided that the application is rejected and recognition/permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993 on the following points. FDRs, if any, be returned to the institution.

- The institution was given show cause notice. The institution did not submit reply of SCN.

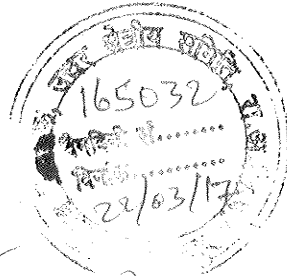
NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 2009, the Northern Regional Committee hereby refuses the recognition/permission to the institution i.e Akshara Academy, Plot No. - 58 K, Village - Eawah, Post Office - Etawah, Tehsil - Sadar, Dist. - Etawah, UP - 206000 for B.Ed. course on the grounds mentioned above.

If the institution is not satisfied by the above order they can prefer an appeal to the Council (NCTE, New Delhi) in terms of section 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the issue of this order.
