REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993 Danta Shikshan Sansthan, Village/Town/City – Danta, Post Office – Danta, Tehsil/Taluka- Dantaramgarh, Town/City- Sikar, District – Sikar, State – Rajasthan, Pin Code – 332702, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Danta Shikshak Prashikshan Sansthan, Plot/ Khasara No.- 2163/7 2163/9, Village – Danta, Post Office – Danta, Tehsil – Danta Rangarh, Town/City – Sikar, District – Sikar, State – Rajasthan, Pin Code – 332702, for B.A./B.Sc/ Course of four years duration on 03.06.2015.

AND WHEREAS, Show Cause Notice before Summarily Rejection was issued to the institution on 02.12.2015 as per 243rd meeting of NRC held from 28th to 30th September, 2015 on the following points: -

- Failure to submit NOC of the affiliating body with the hard copy of the application.

AND WHEREAS, the matter was considered by the NRC in its 256th (Part – 2) meeting held on 22nd to 25th August, 2016 and the Committee decided to issue Show Cause Notice. Accordingly, SCN was issued to the institution on 15.09.2016 on the following points: -


- The applicant institution has not submitted any proof / evidence that it is offering under graduate or post graduate programme of studies in the field of Liberal Arts or Humanities or Social Science or Science or Mathematics for getting grant of recognition for 4 year integrated programme leading to B.Sc, B.Ed. / B.A. B.Ed. degree as has been mentioned in Clause 2(b) of NCTE Regulations, 2014 and clause 1.1 of the Appendix 13 (Norms & Standards for B.A. B.Ed. /B.Sc. B.Ed. degree).

AND WHEREAS, the matter was considered by the NRC in its 270th (Part-2) meeting held from 29th to 30th May, 2017 and the Committee decided that the application is rejected and recognition/ permission is refused u/s 14/15 of the NCTE Act 1993 on the following points:-

- The applicant institution has not submitted the reply of the SCN within the stipulated time.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the application of the institution i.e. Danta Shikshak Prashikshan Sansthan, Plot/ Khasara No.- 2163/7 2163/9, Village – Danta, Post Office – Danta, Tehsil/Taluka – Danta Rangarh, Town/City – Sikar, District – Sikar, State – Rajasthan, Pin Code – 332702, for B.A./B.Ed/B.Sc/B.Ed Course and recognition/ permission is refused on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the online mode available on NCTE's website www.ncte-india.org within 60 days from the issue of this order. The guidelines for filing appeal may be seen on the NCTE website.
