REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993 Jain Educational Welfare Society, Plot No.-662 C, Street/Road-Ishara, Village/Town/City-Ishara, Post Office-Sakit, Tehsil/Taluka-Etah, Town/City- Etah, District-Etah-207001, State- Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. M.M Educational Institute, Plot No.-662 C, Street No.-Ishara, Village-Ishara, Post Office-Sakit, Tehsil/Taluka-Etah, Town/City-Etah, District-Etah-207001, State- Uttar Pradesh for D.El.Ed. Course of two years Duration on 30.06.2015.

AND WHEREAS, the matter was considered by the NRC in its 258th meeting held from 04th to 06th October , 2016 and the Committee decided to issue Show Cause Notice on the following points: -

- The institution has not submitted any proof / evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.
- The institution has not submitted the certified copy of the registered land documents duly certified by the Registrar/Sub-Registrar of the District.
- The institution has not submitted Non-encumbrance Certificate signed by the Competent Govt. Authority.

Accordingly Show Cause Notice was issued on 28.10.2016.

AND WHEREAS, the matter was considered by the NRC in its 271st meeting held from 07th to 09th June, 2017 and decided that the application is rejected and recognition/ permission is refused u/s 14/15 of the NCTE Act ,1993 on the following points:-

The applicant institution has not submitted the reply of SCN within the stipulated period.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3)(b) of NCTE Act. 1993, the Northern Regional Committee hereby rejects the application of the institution i.e. M.M Educational Institute, Plot No.-662 C, Street No.-Ishara, Village-Ishara, Post Office-Sakit, Tehsil/Taluka-Etah, Town/City-Etah, District-Etah-207001, State- Uttar Pradesh for D.El.Ed. Course and recognition/ permission is refused on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the online mode available on NCTE's website www.ncte-india.org within 60 days from the issue of this order. The guidelines for filing appeal may be seen on the NCTE website.
