REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993, Paramjit Singh Principal, Plot Number/Khasara No.- 00, Street/Road- 00, Village/Town/City- Kala Afgana, Post Office- Kala Afgana, Tehsil/Taluka- Batala, Town/City- Kala Afgana, District:- Gurdaspur(PB), State- Punjab, Pin Code- 143513, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to Guru Nanak Govt. College, Kala Afgana (Gurdaspur) PB, Plot Number/Khasara No.- 71/13 etc..(Affidavit), Street/Road- 00, Village/Town/City- Kala Afgana, Post Office- Kala Afgana, Tehsil/Taluka- Batala, Town/City- NA, District:- Gurdaspur(PB), State- Punjab for B.Ed. Course of Two years' duration on 24.07.2015.

AND WHEREAS, the matter was considered by NRC in its 262nd meeting(Part-9) held from 16th to 24th January, 2017 and the Committee decided to issue Show Cause Notice under clause 14/15(3) (b) of NCTE Act,1993, Accordingly, Show Cause Notice was issued on 07.02.2017 on the following grounds: -

- Reply of the LOI issued on 29.05.2015 has not been submitted till date.

AND WHEREAS, the institution has not submitted reply of Show Cause Notice. The matter was considered by NRC in its 269th (Part-2) meeting held from 26th April, 2017 to 02nd May, 2017. The Committee decided to refuse recognition to the institution on the following grounds: -

- The institution has not submitted the reply of the SCN issued by the NRC within the stipulated time.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition/permission sought by the institution i.e Guru Nanak Govt. College, Kala Afgana (Gurdaspur) PB, Plot Number/Khasara No.- 71/13 etc..(Affidavit), Street/Road- 00, Village/Town/City- Kala Afgana, Post Office- Kala Afgana, Tehsil/Taluka- Batala, Town/City- NA, District:- Gurdaspur(PB), State- Punjab for B.Ed. Course on the ground mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.The guidelines for filing appeal may be seen on NCTE website.
