REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993, Badami Bhawna Educational Trust, Plot no. 179/33, Street no. Mathura - Aligarh Road, Village -Koyal, P.O. -Raya, Tehsil -Mant, Town -Raya, District - Mathura -281001, Uttar Pradesh, submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to krishnakulam Educational Institute, Plot no. 179/33, Street no. 0, Village -Koyal, P.O. -Raya, Tehsil -Mant, Town -Raya, District - Mathura -281001, Uttar Pradesh, for D.El.Ed. Course of Two years duration on 30.05.2015.

AND WHEREAS, the matter was considered by NRC in its 243<sup>rd</sup> meeting held from 28<sup>th</sup> to 30<sup>th</sup> September, 2015 and the Committee decided to issue Show Cause Notice under clause 14/15(3) (b) of NCTE Act,1993, Accordingly, Show Cause Notice was issued on 17.11.2015 the following grounds: -

- *Failure to submit NOC of the affiliating body with the hard copy of the application.*

*Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.*

AND WHEREAS, the institution has not submitted reply of Show Cause Notice. The matter was considered by NRC in its 272<sup>nd</sup> meeting held from 06<sup>th</sup> to 07<sup>th</sup> July, 2017. The Committee decided to refuse recognition to the institution on the following grounds: -

- *The applicant institution has not submitted the reply of SCN within the stipulated period.*

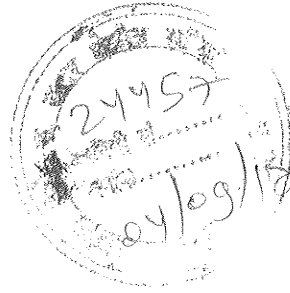
*Hence, the Committee decided that the application is rejected and recognition/ permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.*

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition/permission sought by the institution i.e. krishnakulam Educational Institute, Plot no. 179/33, Street no. 0, Village -Koyal, P.O. -Raya, Tehsil -Mant, Town -Raya, District - Mathura -281001, Uttar Pradesh, for the D.El.Ed. Course on the ground mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order.
