REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993, Sadguru Shiksha Samiti, Plot-No.-15-32, Village/Town/City-Jaipura, Post office-Malviya Nagar, Tehsil/taluka-Sanganer, Town/City-Jaipur, District-Jaipur, State-Rajasthan, Pincode-302017 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Sadguru Institute of Education, Village-Muhana, Post office-Muhana, Tehsil/taluka-Sanganer, Town/City-Jaipur, District-Jaipur, State-Rajasthan, Pincode-302029 for Shiksha Shastri Course of four years duration on 28.05.2015.

AND WHEREAS, Show Cause Notice before Summarily Rejection was issued to the institution on 15.12.2015 as per decision taken in 243rd meeting of NRC held from 28th to 30th September, 2015 on the following points: -

- Failure to submit NOC of the affiliating body with the hard copy of application.

AND WHEREAS, the matter was considered by the NRC in its 250th (Part-6) meeting held on 19th February to 03rd March, 2016 and the Committee decided to issue Show Cause Notice on the following points: -

- Demarcated building plan duly approved by Competent Authority not submitted.
- Certified copies of registered land documents issued by the competent authority have not been submitted.
- Notarized copy of change of land use certificate under clause 143 of UP land Act issued by the competent authority has not been submitted.

AND WHEREAS, the reply submitted by the institution on 15.03.2016 in response to SCN was considered by the NRC in its 252nd (Part-11) meeting held from 19th April to 02nd May, 2016 and the Committee decided to constitute VT. The inspection was conducted on 26.05.2016 and the VTR was received in the office of NRC on 30.05.2016.

AND WHEREAS, the VTR was considered by the NRC in its 255th meeting held from 02nd to 06th August, 2016 and the Committee decided to issue Show Cause Notice on the following points: -

- VT report and other records reveal that at present B.Ed. is being run by the institution for two units with 100 intake which requires 2000 sq.mts. built-up area. The institution has applied for B.Ed. (Shiksha Shastri) programme. Built-up area required for this programme is 1500 sq. mts.. Hence, total construction area needed is 3500 sq.mts. The building completion certificate mentions that total built-up area is 3240.07 sq.mts. which is insufficient for these two programmes.

AND WHEREAS, the reply submitted by the institution on 17.08.2016 in response to SCN was considered by the NRC in its 256th (Part-2) meeting held from 22nd to 25th August, 2016 and the Committee decided to issue Letter of Intent under clause 7(13) of NCTE Regulation, 2014.



AND WHEREAS, the reply of LOI was considered by the NRC in its 261st meeting held on 14th to 19th December, 2016 and the Committee decided to issue Show Cause Notice on the following points: -

- The institution has submitted list of faculty approved by affiliating body, which was approved on 22.10.2010 whereas application was submitted in 2015.
- Name of the institution for B.Ed. (as composite is Sadguru Institution of Professional Education, whereas application is in the name of Sadguru Institution of Education.

AND WHEREAS, the reply submitted by the institution on 26.12.2016 & 13.01.2017 in response to SCN was considered by the NRC in its 263rd (Part-6) meeting held on 06th to 11th February, 2017 and the Committee decided to issue Show Cause Notice on the following points:-

- Request of the institution to change the name of the institution is not acceptable. The institution is required to submit affidavit that both the institution are at the same place.

Accordingly, the SCN was issued to the institution on 16.02.2017.

AND WHEREAS, the reply submitted by the institution on 16.02.2017 was considered by the NRC in its 267th (Part-1) meeting held on 05th to 07th April, 2017 and the Committee decided to issue Show Cause Notice on the following points: -

The reply to SCN dated 16.02.2017 was considered by the NRC and the following observations were made:-

- In the approval list dated 23.02.2016 of the Govt. of Rajasthan, the name of the applicant institution is not appearing.
- The name of the institution in the proof submitted for composite does not match with the applicant institution.

AND WHEREAS, the reply of SCN was considered by the NRC in its 270th (Part-2) meeting held from 29th to 30th May, 2017 and the Committee decided that the application is rejected and recognition/ permission is refused u/s 14/15 of the NRC, NCTE Act 1993 on the following points :-

SCN issued on 02.04.2017 and the reply received on 18.04.2017 were considered and the following observations were made:-

- As per the orders of Govt. of Rajasthan dated 23.02.2016 B.Ed. (Shiksha Shastri) course is banned in Jaipur City (Tehsil- Sanganer) for the session 2016-17, 2017-18 & 2018-19.
- The institution has not submitted any proof / evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3)(b) of NCTE Act. 1993, the Northern Regional Committee hereby rejects the application of the institution i.e. **Sadguru Institute of Education, Village-Muhana, Post office-Muhana, Tehsil/taluka-Sanganer, Town/City-Jaipur, District-Jaipur, State-Rajasthan, Pincode-302029** for Shiksha Shastri Course and recognition/ permission is refused on the grounds mentioned above.



If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the online mode available on NCTE's website www.ncte-india.org within 60 days from the issue of this order. The guidelines for filing appeal may be seen on the NCTE website.
