REFUSAL ORDER /170040

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993, Universal Educational Trust, Plot No. 124, Street No. 5, Village - Shaha Urf Peepal Gaon, Post Office - Peepal Gaon, Tehsil - Sadar, Dist. - Allahabad (UP) 211012, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission Kphel Jhalwa, Plot No. 124, Street No. 5, Village - Shaha Urf Peepal Gaon, Post Office - Peepal Gaon, Tehsil - Sadar, Dist. - Allahabad (UP) 211012, for B.El.Ed. Course of Four years duration on 20.04.2015.

AND WHEREAS, the matter was considered by NRC in its 256th (Part-2) meeting held from 22nd to 25th August, 2016 and the Committee decided to issue Show Cause Notice under clause 14/15(3) (b) of NCTE Act, 1993, Accordingly, Show Cause Notice was issued on 20.09.2016 the following grounds: -

- *The institution has not submitted any proof / evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.*

Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 he issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

AND WHEREAS, the institution has not submitted reply of Show Cause Notice. The matter was considered by NRC in its 260th meeting held from 21st to 23rd November, 2016. The Committee decided to refuse recognition to the institution on the following grounds: -

- *The institution was given show cause notice vide letter dt. 20.09.2016 with direction to submit the reply within 30 days. The institution did not submit any reply of show cause notice till date.*

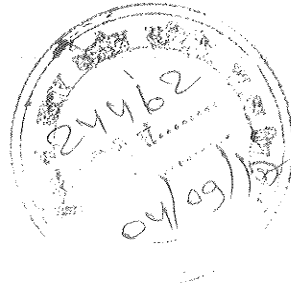
Hence, the Committee decided that the application is rejected and recognition/ permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition/permission sought by the institution i.e. Kphel Jhalwa, Plot No. 124, Street No. 5, Village - Shaha Urf Peepal Gaon, Post Office - Peepal Gaon, Tehsil - Sadar, Dist. - Allahabad (UP) 211012, for the B.El.Ed. Course on the ground mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE website.
