REFUSAL/REJECTION ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Kanpur Public School Society, Plot Number- 3 + Part of 2, Street/Road- G. T. Road, Villge/Town/City- Chakeri Kanpur, Post Office- Harjinder Nagar, Tehsil/Taluka- Kanpur, Town/City- Kanpur, State- UP, District- Kanpur Nagar(UP), Pin Code- 208007 had submitted an application i.e. NRCAPP-6484 to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Kanpur Vocational College, Plot Number- 3 + Part of 2, Street/Road- G. T. Road, Villge/Town/City- Chakeri, Post Office- Harjinder Nagar, Tehsil/Taluka- Kanpur, Town/City- Kanpur, State- UP, District- Kanpur Nagar(UP), Pin Code- 208007 for B.Ed. course on 29.06.2015

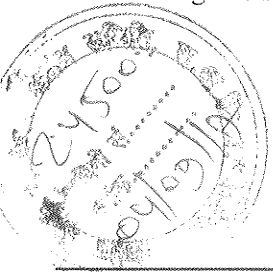
AND, WHEREAS, the matter was considered the NRC in its 266th meeting (Part-1-B) held on 21st to 24th 2017 and the committee decided to issue Show Cause Notice on the following points: -

- The institution has not submitted any proof / evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.
- The institution has not submitted the certified registered land documents issued by the Registering Authority or civil authority concerned.
- The institution has not submitted the Land Use Certificate issued by the Competent Authority to use the land for educational purpose.
- The institution has not submitted the approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area and the measurements of the Multi-purpose Hall as well as the other infrastructural facilities such as class rooms etc.
- The land has been allotted by the Kanpur Development Authority for Residential/School purpose. Accordingly, Show Cause Notice was issued on 29.03.2017.

AND WHEREAS, the institution submitted reply of Show Cause Notice. The matter was considered by NRC in its 270 (Part-2) held on Meeting and the Committee decided that the application of the institution for grant of recognition/permission is refused on the following grounds: -

- The institution has not submitted any proof / evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.
- The institution has not submitted the certified registered land documents issued by the Registering Authority or civil authority concerned.
- The institution has not submitted the Land Use Certificate issued by the Competent Authority to use the land for educational purpose.
- The institution has not submitted the approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area and the measurements of the Multi-purpose Hall as well as the other infrastructural facilities such as class rooms etc.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the said application of the institution i.e. Kanpur Vocational College, Plot Number- 3 + Part of 2, Street/Road- G. T. Road, Villge/Town/City- Chakeri, Post Office- Harjinder Nagar, Tehsil/Taluka- Kanpur, Town/City- Kanpur, State- UP, District- Kanpur Nagar(UP), Pin Code- 208007 and recognition/permission is refused on the grounds mentioned above.





If the institution is not satisfied with order, it may prefer an appeal under Sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal may be seen on NCTE Website.
