REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993, Sri Ghanshyam Mishra Charitable Trust, Plot no. 359, 311/4, Street no. Sujanganj Road, Village -Mungardeeh, P.O. -Mungra badhsahpur, Tehsil - Machhalishahar, Town -Mungra badhsahpur, District -Jaunpur- 222202, Uttar Pradesh, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to Jay Bajrang Mahila Mahavidyalaya, Plot no. 359, 311/4,311/5, Street no. Nal Bazaar, Village -Mungra Badshahpur, P.O. -Mungra badhsahpur, Tehsil -Machhalishahar, Town -Mungra badhsahpur, District -Jaunpur- 222202, Uttar Pradesh, for M.Ed. Course of Two years duration on 16.05.2015.

AND WHEREAS, the matter was considered by NRC in its 266nd (Part-3) meeting held from 21st March to 24th March, 2017 and the Committee decided to issue Show Cause Notice under clause 14/15(3) (b) of NCTE Act, 1993. Accordingly, Show Cause Notice was issued on 04.04.2017 on the following grounds: -

In compliance with the Appellate Authority NCTE, New Delhi order No. 50857 dated 06.03.2017, the institution is directed to clarify the following: -

- How can a Pravakta be designated as Professor or Sah. Professor?
- On what basis the Registrar, VBPU made such addition?
- Where is the order of constitution of Selection Committee?
- Where are the minutes of the constitution of Selection Committee?
- Where is corrigendum order with approval of the competent authority/ Vice- Chancellor of VBPU.
- The affidavit submitted by the institution regarding selection of faculty members is incomplete. The space about the experience of teachers selected has been left blank.

Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

AND WHEREAS, the institution has submitted reply of Show Cause Notice on 31.03.2017. The matter was considered by NRC in its 269th (Part-8) meeting held from 26th April, 2017 to 2nd May, 2017. The Committee decided to refuse recognition to the institution on the following grounds: -

The institution was given show cause notice in compliance with the order of appellate authority on 04.04.2017. The reply of the institution received on 25.04.2017 was considered by the committee & following observations were made: -

- The institution has submitted an approved list of faculty including one HOD and 10 Teachers (Pravaktas) only, issued by affiliating University.
- As per norms of NCTE (Regulations, 2014) for M.Ed. course (P.122), the requirement of faculty is as under: -
 - i. Professor - 2
 - ii. Associates Professors - 2
 - iii. Assistant Professors - 6
- The appointments are not in conformity with the requirement of NCTE Regulations, 2014.

Hence, the Committee decided that the application is rejected and recognition/ permission is refused u/s 14/15 (3)(b) of the NCTE Act, 1993. FDRs, if any, be returned to the institution.

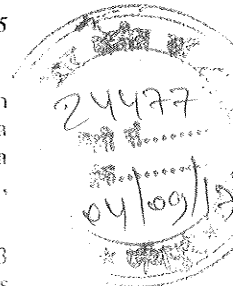
NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition/permission sought by the institution i.e. Jay Bajrang Mahila Mahavidyalaya, Plot no. 359, 311/4,311/5, Street no. Nal Bazaar, Village -Mungra Badshahpur, P.O. -Mungra badhsahpur, Tehsil -Machhalishahar, Town -Mungra badhsahpur, District -Jaunpur- 222202, Uttar Pradesh, for the M.Ed. Course on the ground mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE website.
