REFUSAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993, Dashmesh Educational Society, Plot No. 48, Street/Road- The Edward Ganj Enclave, Village/Town/City- Birla Road, Post Office- Malout, Tehsil/Taluka- Malout, Town/City- Malout, District- Muktsar(PB), State- Punjab, Pin Code- 152107, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission to Dashmesh College of Education, Plot No. Dashmesh College of Education, Street/Road- G. T. Road, Village/Town/City- Theri, Post Office- Theri, Tehsil/Taluka- Giddarbaha, Town/City- Giddarbaha, District- Muktsar(PB), State- Punjab, Pin Code- 152101 for B.A.B.Ed./B.Sc.B.Ed. Course of Four years' duration on 04.08.2015.

AND WHEREAS, the matter was considered by NRC in its 251st meeting(Part-3) held from 07th to 09th April, 2016 (11-13.04.2016) and the Committee decided to issue Show Cause Notice under clause 14/15(3) (b) of NCTE Act, 1993. Accordingly, Show Cause Notice was issued on 23.12.2016 on the following grounds: -

- As per the land documents submitted by the applicant institution, land is on private lease basis thus not as per the clause 8(4)(i) of NCTE Regulations, 2014.
- The Institution has not submitted NOC from the affiliating body.
- Building Completion Certificate on prescribed performa duly certified by competent authority is not submitted.
- Notarized copy of Change of Land Use (CLU) certificate issued by competent authority has not been submitted.
- Blue print of building plan duly approved by (in case of copy signed by) competent local body authority indicating the name & address of institution, total land area, built up area for the proposed course is not submitted.
- The applicant institution has not submitted any proof / evidence that it is offering under graduate or post graduate programme of studies in the field of Liberal Arts or Humanities or Social Science or Science or Mathematics for getting grant of recognition for 4 year integrated programme leading to B.Sc. B.Ed. / B.A. B.Ed. degree as has been mentioned in Clause 2(b) of NCTE Regulations, 2014 and clause 1.1 of the Appendix 13 (Norms & Standards for B.A. B.Ed. / B.Sc. B.Ed. degree).


AND WHEREAS, the institution has not submitted reply of Show Cause Notice. The matter was considered by NRC in its 269th (Part-2) meeting held from 26th April, 2017 to 02nd May, 2017. The Committee decided to refuse recognition to the institution on the following grounds: -

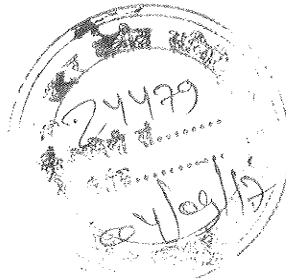
- The institution has not submitted the reply of the SCN issued by the NRC within the stipulated time.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuses recognition/permission sought by the institution i.e Dashmesh College of Education, Plot No. Dashmesh College of Education, Street/Road- G. T. Road, Village/Town/City- Theri, Post Office- Theri, Tehsil/Taluka- Giddarbaha, Town/City- Giddarbaha, District- Muktsar(PB), State- Punjab, Pin Code- 152101 for B.A.B.Ed./B.Sc.B.Ed. Course on the ground mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE website.
