WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993 Eklavya Jan Utthan APPN Sanstha, Plot No-82Kh,83K, Street/ Road-Reew Road Mirzapur, Vill-Bhorsar, Amoi, Mirzapur, Post Office- Amoi, Teh/Taluk- Sadar, Town/City-City, Dist- Mirzapur, (UP), State-UP, Pin-231001, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition / permission to the institution i.e. RC Bind Mahavidhayalya, Plot/Khasara No-83kh,82k, Plot No. 83kh,82k, Street Number-Reewa Road, Vill-Bhorsar, Post Office- Amoi, Teh/Taluk- Sadar, Town/City- Mirzapur, Dist- Mirzapur (UP), State-UP, Pin-231001 for B.Ed. Course of one year duration for an intake of 100 students on 24.12.2012.

AND WHEREAS, the deficiency letter was issued on 08-06-2013 to the institution. The institution did not submit reply to the deficiency letter.

AND WHEREAS, the case of the institution was considered by NRC in its 220<sup>th</sup> Meeting, and as per decision taken by NRC, Show Cause Notice dated 26.11.2013 was issued to the institution on the following points:-

- The deficiencies were communicated to the institution by NRC, vide letter dated 08-06-2013 with the direction to submit the reply of deficiencies within 60 days from the date of deficiency letter. The institution has not submitted its reply to the office of NRC.

The institution did not submit its reply of Show Cause Notice.

AND WHEREAS, the matter was carefully considered by NRC in its 223<sup>rd</sup> Meeting and it was decided that the application of the institution be rejected on the following grounds:

- The institution has not submitted reply of Show Cause Notice.

NOW, THEREFORE, the Northern Regional Committee hereby rejects the above application of the institution i.e. RC Bind Mahavidhayalya, Plot/Khasara No-83kh,82k, Plot No. 83kh,82k, Street Number-Reewa Road, Vill-Bhorsar, Post Office- Amoi, Teh/Taluk- Sadar, Town/City- Mirzapur, Dist- Mirzapur (UP), State-UP, Pin-231001, for grant of recognition for B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of this order.
