Rejection Order

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993, Pragati Educational Society, Plot Number- Kadaraganj, Street/Road- Kadaraganj Bani, Village/Town/City- Kadaraganj Bani, Post Office- Dahiliya Pooth, Tehsil/Taluka- Aliganj, Town/City- Aliganj, District- Etah, Pin Code- 207247, State- Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. P. R. Rajput Degree College, Plot/Khasara No.- 373, 388, 389, 390, 372, 374, 375, Street Number- Sarai Agha, Village- Sarai Aghat, Post Office- Sarai Aghat, Tehsil/Taluka- Aliganj, Town/City- Aliganj, District- Etah, Pin Code- 207250, State- Uttar Pradesh for B.Ed. Course of one year duration for an intake of 100 seats students on 31.12.2012.

AND WHEREAS, after the scrutinizing the application, the following deficiencies were communicated to the institution vide deficiency letter dated 13.07.2013:

- The land is in various khasras. Hence a certificate from the Tehsildar that all khasras are adjacent to each other is required.
- Notarized copy of change of land use certificate issued under clause 143 of UP land Act by the competent authority has not submitted.
- The copy of Change of Land Use Certificate in point no. 5 of affidavit is not submitted. The specific information of land/building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations, 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution. hence, the same is required from the institution in the affidavit (format of the affidavit is enclosed herewith).

AND WHEREAS, the institution had not submitted its reply of the deficiency letter and the matter was carefully considered by NRC in its 220th Meeting and as per decision of NRC, a Show Cause Notice dated 21.11.2013 was issued to the institution on the following grounds:

- The deficiencies were communicated to the Institution by NRC, vide letter dated 13.07.2013 with the direction to submit the reply of deficiencies within 60 days from the date of deficiency letter. The Institution has not submitted its reply to the office of NRC.

AND WHEREAS, The institution had not submitted its reply of the Show Cause Notice and the matter was considered by NRC in its 222nd Meeting and as per decision of NRC, application of the institution be rejected on the following grounds:

- As per decision of NRC, Show Cause Notice under clause 14/15 (3)(b) of NCTE Act, 1993 was issued to the following institutions on ground of non submission of reply of deficiency letter. The time of 30 days was given to submit the reply of Show Cause Notice. Time of 30 days has been expired but, the institution has not submitted the reply of Show Cause Notice. Therefore, NRC decided that the application be rejected under clause 14/15 (3) (b) of NCTE Act, 1993 on ground that the institution has not submitted reply of deficiency letter and Show Cause Notice issued by NRC to the institution and FDRs, if any, submitted by the institution be returned to the institution.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby reject the above application of the institution i.e. P. R. Rajput Degree College, Plot/Khasara No.- 373, 388, 389, 390, 372, 374, 375, Street Number- Sarai Agha, Village- Sarai Aghat, Post Office- Sarai Aghat, Tehsil/Taluka- Aliganj, Town/City- Aliganj, District- Etah, Pin Code- 207250, State- Uttar Pradesh for 100 seats in the B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order. The following FDRs are returned herewith in original.
