**Rejection Order**

WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993 Ishwari Sewa Sansthan, Plot No-196, Street/ Road-Bansgaon Pali Marg link Road, Vill-Majhagawa, Post Office- Bansgaon, Teh/Taluk- Bansgaon, Town/City- Bansgaon, Dist- Ghazipur, State-UP, Pin-273403, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition / permission to the institution i.e. Barhmeshwari Mahila Mahavidyalaya, Plot/Khasara No 00006, Plot No. -196, Street Number- N.A, Vill-Majhagawa, Post Office- Bansgaon, Teh/Taluk- Bansgaon, Town/City- Bansgaon, Dist- Ghazipur, State-UP, Pin-273403 for B.Ed. Course of one year duration for an intake of 100 students on 19.12.2012.

AND WHEREAS, the deficiency letter was issued on 02-05-2013 to the institution. The reply of the deficiency letter was submit on 03-07-2013 by the institution.

AND WHEREAS, The case of the institution was considered by NRC in its 219<sup>th</sup> Meeting, and as per decision taken by NRC Show Cause Notice dated 07.11.2013 was issued to the institution on the following points:-

- Building plan submitted by the institution is approved by the competent authority but not showing plot/Arazi number of the land.

AND WHEREAS, the reply submitted by the institution was considered by NRC in its 223<sup>rd</sup> Meeting and it was decided that the application of the institution be rejected on the following grounds:

- The institution has submitted two different building plans. The building plan submitted in response to Show Cause Notice does not match with the plan submitted the original. The built-up area of the maps read as 2813.59 Sq.mt. and 1800 Sq.mt.(19368 Sq.ft.) respectively, the application. The Signatures of the Gram Panchayat Pradhan on these maps do not match with each other. The institution has mislead the NRC by furnishing verified documents.

NOW THEREFORE, the Northern Regional Committee hereby rejects the above application of the institution i.e. Barhmeshwari Mahila Mahavidyalaya, Plot/Khasara No 00006, Plot No. -196, Street Number- N.A, Vill-Majhagawa, Post Office- Bansgaon, Teh/Taluk- Bansgaon, Town/City- Bansgaon, Dist- Ghazipur, State-UP, Pin-273403 for grant of recognition for B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of this order.
