WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993 Malti Devi Shiksha Prasar Samiti, Plot No - NA, Village - Mainpuri, Post Office - Mainpuri, Tehsil - Mainpuri, Dist. - Mainpuri, UP - 205001 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition / permission to the institution i.e. A K Degree College Jionti Mainpuri, Plot No. - 1326, Village - Jionti, Post Office - Jionti, Tehsil - Jionti, Dist. - Mainpuri, UP - 205001. for B.Ed. Course of one year duration for an intake of 100 students on 26.12.2012.

AND WHEREAS, the deficiency letter was issued on 08.06.2013 to the institution. The institution did not submit reply to the deficiency letter.

AND WHEREAS, the case of the institution was considered by NRC in its 220th Meeting, and as per decision taken by NRC, Show Cause Notice dated 26.11.2013 was issued to the institution on the following points:-

- The deficiencies were communicated to the institution by NRC, vide letter dated 08.06.2013 with the direction to submit the reply of deficiencies within 60 days from the date of deficiency letter. The institution has not submitted its reply to the office of NRC.

The institution did not submit its reply of Show Cause Notice.

AND WHEREAS, the matter was carefully considered by NRC in its 223rd Meeting and it was decided that the application of the institution be rejected on the following grounds:

- The institution has not submitted reply of Show Cause Notice.


