**Rejection Order**

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993 Ansar Educational And Charitable Trust, Plot Number- 251, Street/Road- 0, Village/Town/City- Mumtaz Mahat Ka Hata, Post Office- Golaganj, Tehsil/Taluka- Golaganj, Town/City- Golaganj, District- Lucknow, State- Uttar Pradesh, Pin Code- 226018, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Tanvir College of Education, Plot/Khasra Number- 693, Street Number- 0, Village- Amrai Gaon, Post Office- Amrai Gaon, Tehsil/Taluka- Sadar, Town/City- Lucknow, District- Lucknow, State- Uttar Pradesh, Pin Code- 226018, for D.El.Ed. Course of two years duration for an intake of 50 seats students on 30.09.2011.

AND WHEREAS, the Northern Regional Committee, National Council for Teacher Education in its 211<sup>th</sup> meeting considered the case and NRC decided to issue a Show Cause Notice under clause 14/15 (3) (b) of the NCTE Act 1993. Accordingly, Show Cause Notice was issued to the institution on 12.03.2013 on the following grounds.

- The institution has not replied the letter of Deficiency dated 22.10.2012.

AND WHEREAS, the matter was considered by NRC in its 214<sup>th</sup> Meeting held on 24<sup>th</sup> to 25<sup>th</sup> April, 2013 and it was decided that the application of the institution be rejected on the following grounds :

- The institution has not replied to Show Cause Notice issued by NRC to the institution on 12.03.2013.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby reject the above application of the institution i.e. Tanvir College of Education, Plot/Khasra Number- 693, Street Number- 0, Village- Amrai Gaon, Post Office- Amrai Gaon, Tehsil/Taluka- Sadar, Town/City- Lucknow, District- Lucknow, State- Uttar Pradesh, Pin Code- 226018, for 50 seats in the D.El.Ed. course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of this order.
