WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993 Vijay Gramodyog Evom Samaj Seva Sansthan, Plot No-20,73,103, Street/ Road-Ghazipur Mau Road, Vill- Kardah Kaitholi, Post Office- Mardah, Teh/Taluk- Ghazipur, Town/City- Ghazipur, Dist- Ghazipur, State-UP, Pin-233226 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition / permission to the institution i.e. Shri Abhishek Yadav Prashikshan College, Plot/Khasara No- 20,73,103,56, Plot No. - 20,73,103,56, Street Number- NA, Vill- Nasirpur Dandli, Ghusarupur, Post Office- Ruhipur, Teh/Taluk- Ghazipur, Town/City- Ghazipur, Dist- Ghazipur, State-UP, Pin-233308 for D.El.Ed. Course of Two Years duration for an intake of 50 students on 21/12/2012.

The case of the institution was considered by NRC in its 220th Meeting, and as per decision taken by NRC Show Cause Notice dated 26/11/2013 was issued to the institution on the following points:-

- The deficiencies were communicated to the Institution by NRC, vide letter dated 27/05/2013 with the direction to submit the reply of deficiencies within 60 days from the date of deficiency letter. The Institution has not submitted its reply to the office of NRC.

AND WHEREAS, the reply submitted by the institution was considered by NRC in its 224th Meeting and it was decided that the application of the institution be rejected on the following grounds:

- Notarized copy of change of land use certificate under clause 143 of UP land Act issued by the competent authority has not been submitted.

NOW THEREFORE, the Northern Regional Committee hereby rejects the above application of the institution i.e. Shri Abhishek Yadav Prashikshan College, Plot/Khasara No- 20,73,103,56, Plot No. - 20,73,103,56, Street Number- NA, Vill- Nasirpur Dandli, Ghusarupur, Post Office- Ruhipur, Teh/Taluk- Ghazipur, Town/City- Ghazipur, Dist- Ghazipur, State-UP, Pin-233308 for grant recognition for D.El.Ed. course on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order. The following FDRs are returned herewith in original.
