Rejection Order

WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993 Shiksha Sewa Samiti, Plot No-1507, Street/Road, IDRC, Ahar Bye Pass Road, Vill- Jahangirabad, Post Office- Jahangirabad, Teh/Taluk- Anoopshahr, Town/City- Jahangirabad, Dist- Bulandshahr, State-UP, Pin-202394, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition / permission to the institution i.e. Raghuwar Dayal Prabhu Dayal Institute of Higher Education, Plot/Khasara No. 218 Plot No. -00, Street Number-00, Vill- Shekhupur-Raura, Post Office- Shekhupur-Raura, Teh/Taluk- Anoopshahr, Town/City- Jahangirabad, Dist- Bulandshahr, State-UP, Pin-203150 for B.Ed. Course of one year duration for an intake of 100 students on 16.12.2012.

AND WHEREAS, the deficiency letter was issued on 16-04-2013 to the institution. The reply of the deficiency letter was submitted on 29-05-2013 by the institution.

AND WHEREAS, the case of the institution was considered by NRC in its 218th Meeting, and as per decision of NRC, VT was constituted to verify the infrastructure & Instructional facilities created by the Institution for B.Ed. Course as per the provisions of NCTE Regulation, 2009 for further processing of the application.

AND, WHEREAS the inspections of the institution was conducted on 04.10.2013.

AND, WHEREAS, the matter was carefully considered by NRC in its 221st Meeting and as per decision taken by NRC, Show Cause Notice dated 08.01.2014 was issued to the institution on the following points:-

- As per the complaint received alongwith copy of prospectus of the institution, copy of website of the Chaudhary Chanran Singh University, Meerut, Uttar Pradesh, the institution is running B.Com, BCA. In online application & affidavit, the institution has hide these facts and has tried to mislead the NRC-NCTE.
- The institution has also not submitted building plan duly approved & earmarked under clause 8(7)(ii) of NCTE Regulations, 2009.

AND WHEREAS, the reply submitted by the institution was considered by NRC in its 225th Meeting and it was decided that the application of the institution be rejected on the following grounds:

- The institution has again tried to mislead the NRC by mentioning that affiliations for B.Ed. & BCA course were not received before 16.12.2012 (The date of submission of application for grant of recognition for B.Ed. course) vide its letter 30.01.2014. Affiliations for BCA & B.Com course are effective from 01.07.2012.
- Shiksha Sewa Samiti Jahangirabad, Distt. Bulandshahr is running two institutions viz., Raghuardayal Prabhudayal Girls P.G. College and Raghuardayal Prabhudayal Institute of Higher Education. Prospectus of Raghuardayal Prabhudayal Girls P.G. College shows that BA, B.Com, MA Home Sci., MA English & B.Ed. course are being run by the Mahavidyalaya and the college established in 2002.
- Raghuardayal Prabhudayal Institution of Higher Education is also running BCA & B.Com course and has also applied for B.Ed. course Shiksha Sewa Samiti has not constructed any separate independent building for the proposed B.Ed. course as the total built-up area of the institution mentioned at Sr. No. 15 of Building Completion Certificate dated 08.12.2012 is only 2320 Sq.mt., which is even not sufficient for the two courses viz., BCA & B.Com already being run by the society.

NOW, THEREFORE, the Northern Regional Committee hereby rejects the above application of the institution i.e. Raghuwar Dayal Prabhu Dayal Institute of Higher Education Plot/Khasara No. 218 Plot No. -00, Street Number-00, Vill- Shekhupur-Raura, Post Office- Shekhupur-Raura, Teh/Taluk- Anoopshahr, Town/City- Jahangirabad, Dist- Bulandshahr, State-UP, Pin-203150 for grant of recognition for B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order.
