REFUSAL/REJECTION ORDER

27 DEC 2016

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Maruti Educational Trust, Plot / Khasra No.1, Street / Road - Sector-17-A, Village/Town/City - Greater Noida, Post Office - Dankaur, Tehsil / Taluka - Sadar, Town/City - Greater Noida, District - Gautam Budha Nagar, State - Uttar Pradesh, Pin Code - 203201 had submitted an application i.e. NRCAPP-14628 to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Noida International University, Plot / Khasra No.1, Street / Road - Sector-17-A, Village - Dankaur, Post Office - Dankaur, Tehsil / Taluka - Sadar, Town/City - Greater Noida, District - Gautam Budha Nagar, State - Uttar Pradesh, Pin Code - 203201 for BA/B.Sc. course on 29.06.2015.

AND WHEREAS, the matter was considered by NRC in its 257<sup>th</sup> (Part-3) Meeting held from 05<sup>th</sup> to 11<sup>th</sup> September, 2016 and the Committee decided to issue Show Cause Notice on the following grounds: -

- Letter of intent under clause 7(13) was issued to the institution on 27.06.2016. The institution has not submitted the reply of the LOI within stipulated time.

Accordingly Show Cause Notice was issued on 27.09.2016 to the institution.

AND WHEREAS, the institution did not submit reply of Show Cause Notice. The matter was considered by NRC in its 261<sup>st</sup> Meeting held from 14<sup>th</sup> to 19<sup>th</sup> December, 2016 and the Committee decided that the application of the institution for grant of recognition/permission is refused on the following grounds: -

- The institution has not submitted the reply of show cause notice dated 31.08.2016 issued by the NRC, NCTE in stipulated time period.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the said application of the institution i.e. Noida International University, Plot / Khasra No.1, Street / Road - Sector-17-A, Village - Dankaur, Post Office - Dankaur, Tehsil / Taluka - Sadar, Town/City - Greater Noida, District - Gautam Budha Nagar, State - Uttar Pradesh, Pin Code - 203201 and recognition/permission is refused on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under Sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte.india.org](http://www.ncte.india.org) within 60 days from the date of this order. The guidelines of appeal may be seen on NCTE Website.
